THE CITY OF EDINBURGH COUNCIL (CCWEL SECTION 1 Q1, EDINBURGH) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 – TEMP/22/28

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (CCWEL Section 1 Q1, Edinburgh) (Temporary Road Restriction and Traffic Regulation) Order 2022”. The Order shall come into operation on the Seventh day of February Two thousand and twenty-two and shall remain in force up to and including the Second day of June Two thousand and twenty-two.
2. In this Order the following phrases have the meanings respectively assigned to them:

“Article” means an Article of the Order;

“emergency service vehicle” means a vehicle being used for ambulance, fire or police purposes;

“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;

“road” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;

“residents” means a person residing in a property that fronts, or has access restricted by a restriction within this Order.

“Schedule” means a Schedule to this Order; and

“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate footway improvement and cycleway construction works, no person shall (as signed as affected by the works):
 - (a) drive or cause or permit to be driven any vehicle on parts of the roads specified in Schedule 1 hereto;
 - (b) cause or permit any person to walk on the footways described in Schedule 2 of this Order hereto;
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to park, wait or load onto or unload from any vehicle on the sections of road described in Schedule 3 to this Order hereto; and
 - (d) drive or cause or permit to be driven any vehicle on the road described in column 1 of Schedule 4 so as to make the prohibited turn specified in column 2 of Schedule 4, into the road specified in column 3 of Schedule 4 hereto.
4. Nothing in:
 - i. Article 3(a) of this Order shall apply to emergency service vehicles and residents, in relation to the closure of Balbirnie Place; and
 - ii. Article 3 of this Order shall apply to vehicles connected to the works.
5. ‘The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018’ is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

6. The alternative route for through vehicular traffic in respect of the closures will be by way of (i) **Wester Coates Terrace** - Wester Coates Avenue and Wester Coates Road; (ii) **Wester Coates Road** – Wester Coates Terrace and Wester Coates Avenue; and (iii) **Murrayfield Place** – Murrayfield Avenue and Corstorphine Road.

SCHEDULE 1 ROAD CLOSURES

- (i) **Balbirnie Place**, at its junction with Roseburn Terrace (*except emergency service vehicles and residents*); (ii) **Wester Coates Terrace**, at its junction with Roseburn Terrace; (iii) **Wester Coates Road**, at its junction with Hampton Road; and (iv) **Murrayfield Place**, from a point 15 metres of thereby east of its junction with Murrayfield Avenue, southwards to its junction with Roseburn Terrace.

SCHEDULE 2 FOOTWAY/FOOTPATH CLOSURES – PEDESTRIAN TRAFFIC

- (i) **West Coates**, from its junction with Devon Place and its junction with Stanhope Street; (ii) **Kew Terrace/Hampton Place**, from its junction with Stanhope Street and its junction with Balbirnie Place; (iii) **Roseburn Terrace**: (1) from its junction with Balbirnie Place and its junction with Roseburn Street (*including the footpath from Roseburn Terrace to Russell Road*); and (2) from its junction with Roseburn Street and its junction with Roseburn Gardens; (iv) **Corstorphine Road**: (1) from its junction with Ormidale Terrace and its junction with Murrayfield Gardens; (2) from its junction with Murrayfield Gardens and its junction with Murrayfield Avenue; & (3) from its junction with Murrayfield Avenue and its junction with Murrayfield Place; (v) **Roseburn Terrace**: (1) from its junction with Murrayfield Avenue and its junction with Roseburn Cliff; and (2) from its junction with Roseburn Cliff and its junction with Wester Coates Terrace; (vi) **Roseburn Terrace/Kew Terrace**, from its junction with Wester Coates Terrace and its junction with Wester Coates Road; and (vii) **West Coates**, from its junction with Wester Coates Road and its junction with Donaldson Crescent.

SCHEDULE 3 PROHIBITION OF PARKING, WAITING, LOADING & UNLOADING

- (i) **West Coates/Roseburn Terrace**, from the western-most kerb of Devon Place for a distance of 310 metres or thereby westwards to the eastern-most kerb of Roseburn Gardens (*including the layby at "The Bathroom Company"*); (ii) **Murrayfield Place**, along the entirety of the southern kerbline and the adjacent pedestrian bridge; and (iii) **Wester Coates Terrace**, *west side*, from its junction with Roseburn Terrace for a distance of 50 metres or thereby in a northward direction.
