Appendix 2: Conditions for installation of WiFi or similar equipment in taxis or private hire vehicles .

- 1. Each licence holder shall submit a variation of licence application to the Council <u>prior</u> to installing any such equipment and shall submit the relevant vehicle for inspection, paying the relevant inspection fee.
- 2. Once inspected the equipment will be checked as required as part of the normal inspection of the vehicle and no additional fee will be required unless new or alternative equipment is installed.
- 3. The licence holder shall supply any document, type approval or test certificate relevant to the equipment as required by the Cab Inspector or the Council.
- 4. The licence holder will remain responsible for ensuring that all relevant legislation is complied with and in particular the Data Protection Act 2000.
- 5. The equipment shall not be used in any way that breaches the privacy of any user nor shall any information, or data collected by the equipment, be disseminated without the express knowledge and permission of the user.
- 6. The agreement of the Council and or the Cab Inspector to install any such equipment is not an endorsement of the equipment. Nor shall it be described as 'Council approved' or any similar term.
- 7. The Council delegates to the Cab Inspector and examiners at the Taxi Examination Centre the power to inspect and agree that equipment is appropriate and safe.
- 8. The Council reserves the right to amend or remove any permission either generally or in the case of an individual licence upon determination of any complaint upheld by the Council.
