The provision of this service will enhance the rights to physical security, productive and valued activities and individual, family and social life for the young people involved. The service promotes the liberty of young people within the parameters of keeping them and others safe. Support from the providers will be for children and young people who require intensive support either with or without a Movement Restriction Condition (MRC). As highlighted in the ERIA for the Alternatives to Secure Care – Intensive Support and Electronic Monitoring procedure depriving a child/young person of their liberty in any form will only be imposed as a last resort and for the shortest period possible. The views of the child/young person and their parents/cares will be obtained at the earliest opportunity and considered as part of the MRC assessment. An MRC will not be pursued where there is not agreement from the child/young person, parents or the carer where the child resides.

Children/young people who are looked after will be entitled to support by the council's Children's Rights Team and Who Care? Scotland. Their entitlement to this support will be promoted both by the staff of the Young People's Service and the commissioned service.

Young people will be referred to the service and their needs assessed on an individual basis. Within the contract there will be an equalities statement stating that it is the duty of the commissioned service to comply with the Equalities Act 2010. Issues of non compliance will be picked up through regular partnership working (team around the child) and monitoring of the service. In the specification it states that 'The provision of the service will be governed by enacted legislation and indicative "best practices" for the industry, as well as the City of Edinburgh Council policies.

At present Edinburgh has a higher proportion of young woman in secure care compared to other local authorities. This new service may impact on the number of young woman in secure care either through providing support to make the transition away from secure care or strengthening support in community settings to prevent the need for secure care.
