The contract with Stepping Stones will finish on 31st March 2020 and the services covered by the contract will no longer be delivered by the organisation. An additional consideration is that Stepping Stones is based within Granton Early Years Centre and uses some facilities that then precludes use by CEC staff based in the Centre.
