They will be allowed to purchase soft drinks from the bar. Also to provide that Children under 5 may have access. Children will be permitted to remain until 1 0pm on the premises unless attending a private pre-booked function in which case they may remain until the end of the function or 1am whichever is earlier. Young Persons must vacate the premises by 1am. Also to clarify that the areas accessible by Children and Young Persons are as shown on the Layout Plan. To add a Premises Manager. To submit a new Layout Plan, in addition to the current Layout Plan, to show the outside area where members and visitors may consume alcohol.
