The Social Work expenditure above includes funds which will be transferred to the Integration Joint Board. This transfer will be supplemented by Health Board funding and additional Scottish Government support through the Social Care Fund.

Year on Year movement in Roads and Transport, Planning and Other primarily relates to the net effect of a number of ongoing impacts of the Covid-19 pandemic, including the loss of the Lothian Buses dividend, increased required support for the Council's Arms Length External Organisations and anticipated income losses within parking and commercial rentals.
