1. Welcome and Apologies

2. Minutes of Meeting 14th October 2020 – circulated

The note was proposed by MA and seconded by DT

3. Action Tracker 14th October 2020 - circulated

The action tracker had been updated and circulated.

4. North East Locality Improvement Plan Progress Update–Evelyn Kilmurry, NE Locality Manager

EK gave a presentation which provided members with an overview of the work which has been taken forward to develop the newly reframed NE Locality Improvement Plan.

It was reported that the Edinburgh Partnership had approved all four reframed LIP's at their meeting on the 15 December and had agreed to receive a further report later in 2021. EK updated the LCPP on the NE locality workplan, highlighting the progress had been made in identifying performance measures and in the mapping activity across from the previous plan. Meetings with priority leads and partners have taken place over the last month with a focus on next steps including the refresh of the working groups that will take the work forwards and the development of the workplans that sit beneath the three high level priorities that will include the detail of the work required to be delivered over the next 15-month period.

EK provided an overview of the approaches for each priority area.

Priorities

Priority 1 - Susie Donkin, Economic Development, is the lead for priority 1 where partners will be taking forward work to address youth employability. Susie will be refreshing the membership of the NE Employability Partnership Group. This priority also includes focused work on Youth Talk with an employability theme where Scott Neill, Lifelong Learning Services will provide support.

Priority 2 – AL outlined the approach she plans to take including a refresh of the previous Health & Wellbeing LIP planning group with the key aspiration to work on building existing established partnerships. AL explained that the group would be taking the next four weeks to review the current position.

Digital inclusion will be a key area of focus and it was acknowledged that there has been much progress here throughout the last ten months. Following the initial review period high level actions will be identified. Planning includes a desire to refresh the governance group without the subgroups. There are clear synergies within this group that cut across the other priority areas.

Priority 3 – EK will lead on this priority together with Chief Inspector MT from Police Scotland. Actions in the Place theme are aimed at improving people's quality of life, tackling those areas most in need with a focus on community safety and key environmental issues. Libby Strong, NE Housing Manager will take forward work with partners in Northfield, Magdalene and North Cairntow as priority focus areas. It is recognised that community engagement is at the core of this theme with partnership groupings currently being formed and refreshed to support the involvement of local people in the work.

MT outlined the work that will be undertaken to tackle domestic abuse, hate crime and anti-social behaviour by refreshing and strengthening the actions within the Community Improvement Partnership working group. Inspector Fordyce and local sergeants have been tasked with leading each of the three areas of community safety work and looking afresh at existing approaches.

EK advised that she will be looking at creating a small cross priority working group to ensure that there's an integrated approach to taking forward the work and will also support partners in providing regular progress updates to the LCPP. She asked the LCPP how they would like to see progress reported at future meetings, either with an overview or with a more specific themed approach.

Progress reporting/ Impact of Covid

There followed a discussion on progress reporting and the impact of covid on ambitions set out in the Plan. RG advised that there did not need to be the same approach to performance reporting at every LCPP meeting and that both a general and themed approach would work. It was suggested that a different performance focus at each meeting such as 'deep dives' to specific improvement areas could work well.

MM explained that strategically there is a desire for improved coherency across performance and business plans and a recognised need for alignment to reflect Poverty Commission findings and Community Plan priorities – this is reflected in the recently published Council Business Plan. RG acknowledged a need to avoid any duplication of effort.

WB expressed concern about the realities of the current situation and asked the group to consider the possibility of taking some time out to review where we are right now. MM explained that this was also raised at the Edinburgh Partnership meeting and there was agreement that the Community Plan (LOIP) is a ten-year plan and it may be sensible to have something additional in place to cover Covid related issues and challenges. EK advised that the Plan was shaped in the light of the learning from the last ten months and that aspiration to tackle some of the priorities is even more heightened e.g. domestic abuse. RG added that it would be good to hear from the Edinburgh Partnership that they recognise we are operating differently under Covid and that we are in a worse position due to covid. There was a request to have this acknowledgement in writing.

Decision – MM agreed to investigate this further.

AS expressed a need for more high level information on the present situation e.g. school leaver's destinations- have they been affected by covid and what has changed? MM agreed to discuss with Susie Donkin as NE employability priority lead to determine any information about attainment levels/ link in with CCP.

Decision – MM to work with EK to get additional statistical information on school leaver's destinations/ attainment levels.

5. Neighbourhood Networks

EK provided a progress update and advised that there has been a citywide pause on Network development work but that a workshop is being planned for all 13 Networks to take place in a 2-3 weeks time. An invitation to participate will be sent to each Network and the session will provide the opportunity for representatives to share learning on what has worked and what hasn't worked and then consider future steps.

6. Edinburgh Partnership Update - Michele Mulvaney, Strategy Manager, Strategy & Communications

MM made the group aware that as a result of the recently published Best Value Assurance report that a sub-group is being set up by the Edinburgh Partnership Board which is tasked with developing an improvement plan to address the findings relating to partnership working and community engagement.

7. Thrive Project – Linda Irvine Fitzpatrick, NHS Lothian

LIF gave a presentation providing an overview of the Thrive Project which is seeking to 'Change the Conversation' and 'Change the

Culture' to improve Mental Health Awareness amongst people and communities.

Key Points -

- New website since 12th October and now a Thrive Line is live.
- The Thrive Pillar asks, 'What is in the Thrive Exchange?'measuring Community Resilience and developing the Thrive network.
- Thrive values have been developed and published with 6 simple outcomes including 3 system and financial based outcomes.
- Prototyping of Thrive teams in the North East began on 22 June 2020 and we have seen 65 people with an average age of 40 having initial conversations.
- Workstreams include: 'A Place to Live', 'Meeting Treatment Gaps', 'Building Resilient Communities' and 'Addressing Inequalities'.

LIF encouraged people to get involved.

MA explained the process which is that once the team are well formed, they then reach out to other agencies. Initially, building strong local relationships will be the priority.

Decision - LIF agreed to circulate to the group results of an evaluation on initial conversations and progress.

8. Seafield Planning – Douglas Tharby, Leith Neighbourhood Network

DT highlighted the importance of community representation on the LCPP.

DT provided an update on the Seafield Road Development Plans advising that networking has taken place across 4 Community Councils in addressing the question of development in the area. The Seafield land lies within the Craigentinny & Duddingston ward, although a much wider area would be impacted and a 'Seafield Sounding Board' has met once which included representation from the other areas concerned. DT advised that a PAN has been submitted for the Western end of the site. There is local concern that in the absence of a full City Plan, developers may take a fragmented approach to the area rather than providing a mixed development which would include amenities and other services. DT expressed the importance of any development providing "homes" for people and not just "houses" and hoped that the LCPP would support that aspiration.

RG mentioned other forums for more in-depth discussion on planning considerations but welcomed sharing the information with the group.
