WELCOME TO THE FIRST EDITION OF A NEWSLETTER FOR THE TENANTS AND RESIDENTS AT MAGADALENE GARDENS AND DRIVE.

The City of Edinburgh Council's aim is to improve the condition of blocks of flats which include both privately owned and Council owned flats.

In 2019 and 2020 workshops were held to discuss your priorities for investment in your blocks at Magdalene Gardens and Drive. The key themes from the workshop, along with an update of works that have been completed since the workshop are detailed below:

Key Themes from the workshop:	Update on works completed since workshop:	Status
Waste management	Since the workshop was held in October 2020, Waste Services have been working to relocate the bins to the end of the blocks in hard standing bin stores.	Ongoing
Improvements to balcony blocks	Agree proposals for the external building designs (This was due to take place in March 2021 but was postponed due to Covid).	Ongoing
Back courtyards and open space	Consultation will take place in April 2022.	Ongoing

PROPOSED IMPROVEMENTS TO YOUR BLOCK

Due to the Covid 19 pandemic, there has been a delay in taking forward the next stage of consultation with tenants and owners and the works programme. We are now however ready to seek your views on proposals to the blocks.

Renovations to the blocks and courtyards will be split into 2 parts. The 1st part of the works to be completed will be improvements to the external of the blocks.

The table below shows the proposed work that will be carried out on the blocks to make your homes warmer and more energy efficient.
