THE CITY OF EDINBURGH COUNCIL (STOCKBRIDGE & ROYSTON AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/96

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Stockbridge & Royston Area) (Temporary Road Restriction and Traffic Regulation) Order 2022" and shall come into operation on the First day of June Two thousand and twenty-two and shall remain in force up to and including the Thirtieth day of November Two thousand and twenty-two.
2. In this Order the following phrases have the meanings respectively assigned to them:  
"Article" means an Article of this Order;  
"emergency service vehicles" means a vehicle being used for ambulance, fire or police purposes;  
"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;  
"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and  
"Schedule" means a Schedule to this Order.
3. Save as provided in Article 4 of this Order, to facilitate CityFibre ducting works, no person shall (as signed as affected by the works): -
  - (a) drive or cause or permit to be driven any vehicle on sections of the roads described in Schedule 1 to this Order hereto, where closures apply to roads in their entirety unless otherwise stated; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on (i) **Arboretum Place**; (ii) **Bedford Court**; (iii) **Bedford Street**; (iv) **Cheyne Street**; (v) **Dean Park Street**; (vi) **Mary's Place, south side**, in its entirety; (vii) **Portgower Place**; (viii) **Raeburn Mews**; (ix) **Raeburn Place**; (x) **Boswall Parkway**; (xi) **Pilton Drive North**; (xii) **Royston Mains Avenue**; (xiii) **Royston Mains Close**; (xiv) **Royston Mains Gardens**; (xv) **Royston Mains Green**; (xvi) **Royston Mains Place**; (xvii) **Royston Mains Road**; (xviii) **Royston Mains Street**; and (xix) **Wardieburn Place West**, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
4. Nothing in Article 3 shall apply to emergency vehicles any vehicle connected with the works.
5. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

6. Access for through vehicular traffic will be by way of the roads described in Column 3 of Schedule 1. Pedestrian access will be maintained.
