THE CITY OF EDINBURGH COUNCIL (NEWBATTLE TERRACE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/99

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Newbattle Terrace Area) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Thirtieth day of May Two thousand and twenty-two up to and including the Twenty-seventh day of November Two thousand and twenty-two.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order:
 - "emergency service vehicles" means a vehicle being used for ambulance, fire or police purposes;
 - "Parking attendant" has the same meaning as in Section 63A of the 1984 Act; "road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this order, includes part of a road; and "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate public realm works, no person shall (as signed as affected by the works):
 - (a) drive or cause or permit to be driven any vehicle on (i) **Newbattle Terrace**, at its junction with Morningside Road; (ii) **Falcon Gardens**, at its junction with Newbattle Terrace; (iii) **Pitsligo Road**, at its junction with Newbattle Terrace; (iv) **Eden Lane**, at its junction with Newbattle Terrace; and (v) **Woodcroft Road**, at its junction with Newbattle Terrace (at rear private car park entrance); and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i) **Newbattle Terrace**, between its junction with Morningside Road and its junction with Eden Lane; and (ii) **Falcon Gardens**, between its junction with Newbattle Terrace and its junction with Falcon Avenue.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or any vehicles connected to the works.
- 5. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' will be suspended in so far as it is affected by the measures outlined in Article 3(b) of this Order.

6. The alternative route for through vehicular traffic will be by way of: (i) **Newbattle Terrace** – Morningside Road, Church Hill Place & Pitsligo Road; (ii) **Falcon Gardens** – Newbattle Terrace, Morningside Road & Falcon Avenue; (iii) **Pitsligo Road** – Newbattle Terrace, Morningside Road & Church Hill Place; (iv) **Eden Lane** – no diversion available, access maintained; & (v) **Woodcroft Rd** – no diversion available, access maintained.
