



THE CITY OF EDINBURGH COUNCIL (GILMERTON ROAD) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/74

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Gilmerton Road) (Temporary Road Restriction and Traffic Regulation) Order 2022" and shall come into operation on the Seventh day of June Two thousand and twenty-two and shall remain in force up to and including the Fifth day of December Two thousand and twenty-two. The circumstances necessitating the restrictions within this Order, as stated in Article 2, will be subject to ongoing review and should it be determined that the restrictions are no longer required, then at that time the temporary restrictions shall be revoked by notice, under a separate Order.
2. To facilitate improved safety for pedestrians and cyclists during the current Covid-19 pandemic, supporting social distancing so that people can safely walk, wheel or cycle, no person shall, (as signed as affected by the works) except with the permission of a Parking Attendant, cause or permit any vehicle to wait, load or unload from any vehicle, at any time, on any part of the road described in the Schedule to this Order.
3. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' is hereby suspended in so far as it is affected by the measures described in Article 2 of this Order.

**SCHEDULE**  
**PROHIBITION OF WAITING, LOADING & UNLOADING**

**Gilmerton Road** (a) *north side (eastbound)*: (i) from a point 3 metres or thereby east of the extended eastern kerbline of Liberton Road, eastwards for a distance of 43 metres or thereby; (ii) from a point 66 metres or thereby east of the extended eastern kerbline of Liberton Road, eastwards for a distance of 54 metres or thereby to its junction with Old Mill Lane; (iii) from the extended eastern kerbline of Old Mill Lane, eastwards for a distance of 33 metres or thereby; (iv) from a point 155 metres or thereby west of the extended western kerbline of Glenallan Drive, westwards for a distance of 16 metres or thereby to the entrance of Liberton Primary School; (v) from the extended western kerbline of Glenallan Drive, westwards for a distance of 112 metres or thereby; (vi) from the extended eastern kerbline of Glenallan Drive, eastwards for a distance of 58 metres or thereby; (vii) from a point 83 metres or thereby east of the extended eastern kerbline of Glenallan Drive, eastwards for a distance of 237 metres or thereby; (viii) from a point 240 metres or thereby east of the extended eastern kerbline of Glenallan Drive, eastwards for a distance of 13 metres or thereby; and (ix) from the extended western kerbline of Walter Scott Avenue, westwards for a distance of 66 metres or thereby; and (b) *south side (westbound)*: (i) from a point 25 metres or thereby east of the extended eastern kerbline of Rutherford Drive, eastwards for a distance of 9 metres or thereby; (ii) from the extended eastern kerbline Rutherford Drive, eastwards for a distance of 22 metres or thereby; (iii) from the extended western kerbline of Rutherford Drive, westwards for a distance of 198 metres or thereby; (iv) from a point 247 metres or thereby west of the extended western kerbline of Rutherford Drive, westwards for a distance of 34 metres or thereby; (v) from the extended eastern kerbline of Double Hedges Road, eastwards for a distance of 39 metres or thereby; (vi) from the extended western kerbline of Double Hedges Road, westwards for a distance of 79 metres or thereby; (vii) from the extended eastern kerbline of Orrok Park, eastwards for a distance of 34 metres or thereby; (viii) from the extended western kerbline of Orrok Park, westwards for a distance of 83 metres or thereby; and (ix) from the extended eastern kerbline of Liberton Road, eastwards for a distance of 107 metres or thereby to its junction with Nether Liberton Court.
