THE CITY OF EDINBURGH COUNCIL (HOLYROOD WEEK & GARDEN PARTY 2022) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/114

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Holyrood Week & Garden Party 2022) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Twenty-second day of June Two thousand and twenty-two up to and including the First day of July Two thousand and twenty-two, during the hours specified in the Schedules to this Order.
2. (a) In this Order the following phrases have the meanings respectively assigned to them:
"Article" means an Article of this Order;
"emergency service vehicle" means a vehicle being used for ambulance, fire or police purposes;
"event related vehicle" means any vehicle authorised by City of Edinburgh Council as being connected with this event, and for the purposes of this Order, includes event related coaches/buses;
"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
"road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this order, includes part of a road;
"Schedule" means a Schedule to this Order;
"taxi" has the same meaning as in Section 23 of the Civic Government (Scotland) Act 1982;
and
"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
(b) References in this Order to a disabled person, to a disabled person's badge, to a disabled person's vehicle and to a vehicle displaying a disabled person's badge in the relevant position shall be construed in accordance with the 1984 Act, The Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000 and The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002.
3. Save as provided in Article 4, to facilitate venue security and the safety of participants in the events, and to minimise the impact on the surrounding road network, no person shall (as signed as affected by the event):
 - (a) drive or cause or permit to be driven any vehicle on the roads specified in Schedule 1 hereto, during the times and dates specified in Schedule 1. Closures will apply to the road in its entirety unless otherwise stated;
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the roads described in Schedule 2 hereto, during the times and dates specified in Schedule 2. Prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
4. Nothing in:
 - (i) Article 3 shall apply to emergency service vehicles;
 - (ii) Articles 3(a) and (b) shall apply to event related vehicles in relation to the sections of **Holyrood Road, Holyrood Gait and Horse Wynd**, during the dates and hours specified in Schedules 1 and 2 to this Order.

5. Nothing in Article 3(b) shall apply: -
- (a) so as to prevent any person from causing or permitting a vehicle to wait in any road described in said Schedule while the vehicle is in actual use for the purpose of delivering or collecting goods or while loading or unloading goods from or to premises adjoining the said road; provided that:
 - i. no such vehicle so engaged shall wait for a period of more than thirty minutes in the same place; and
 - ii. no such vehicle so engaged shall return to the same place, unless a period of more than thirty minutes has elapsed since the termination of the previous waiting period.
 - (b) to a vehicle displaying a valid disabled person's badge, provided that said vehicle is being used by, or for the conveyance of, the holder of a valid disabled person's badge.
6. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' will be suspended during the times and on the dates specified in the Schedules on any of the affected sections of roads described.
7. The alternative route for through vehicular traffic, in respect of the closures will be by way of Canongate and St Mary's Street.

SCHEDULE 1
ROAD CLOSURES

From 07:00 hours on 22/06/2022 to 19:00 hours on 01/07/2022 on:

(1) **Abbey Strand**; (2) **North Approach**; and (3) **Horse Wynd** (*to be facilitated by Police Scotland for short periods within the times stated*).

From 13:00 hours to 19:00 hours on 29/06/2022 on:

(1) **Holyrood Road (eastbound)** (*except for local access/drop-off/collection of event related guests*); (2) **Holyrood Gait** (*except for local access/drop-off/collection of event related guests*); and (3) **Horse Wynd** (*except for local access/drop-off/collection of event related guests*).

SCHEDULE 2
PROHIBITION OF WAITING, LOADING AND UNLOADING

From 07:00 hours on 22/06/2022 to 19:00 hours on 01/07/2022 on:

(1) **Abbey Strand**; (2) **North Approach**; (3) **Canongate, both sides**, from its junction with Abbeyhill, westwards for a distance of 50 metres or thereby (*including taxi rank*); (4) **Abbeyhill, both sides**, between its junction with Canongate and its junction with Croft-an-Righ; (5) **Croft-an-Righ**; and (6) **Horse Wynd** (*except disabled bay*).

From 07:00 hours to 19:00 hours on 27/06/2022 on:

Horse Wynd, disabled bay on *east side* (*except event related vehicles*).

From 07:00 hours to 19:00 hours on 29/06/2022 on:

(1) **High Street, both sides**, between its junction with South Gray's Close and its junction with St Mary's Street; (2) **Canongate**; (3) **Abbey Mount**; (4) **Horse Wynd**, disabled bay on *east side*; (5) **Holyrood Gait** (*except drop-off/collection of event related guests*); (6) **Holyrood Road** (*except drop-off/collection of event related guests*); and (7) **Holyrood Park Road**.
