THE CITY OF EDINBURGH COUNCIL (DRUM STREET AREA) (NO. 2) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/61

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Drum Street Area) (No. 2) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Twenty-seventh day of June Two thousand and twenty-two up to and including the Twenty-sixth day of August Two thousand and twenty-two.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 "emergency service vehicles" means a vehicle being used for police, fire or ambulance purposes;
 "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; and "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate public realm works, no person shall (as signed as affected by the works):
 - (a) drive or cause or permit to be driven any vehicle on (i) Drum Street, between its junction with Ferniehill Drive and its junction with Gilmerton Station Road; (ii) Ravenscroft Street, at its junction with Drum Street; (iii) East Farm of Gilmerton, at its junction with Drum Street; (iv) Limefield, at its junction with Drum Street; (v) Drum Cottages, at its junction with Drum Street; (vi) Candlemaker's Park, at its junction with Drum Street; and (vii) Carter Drive, at its junction with Drum Street; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on (i) Drum Street, *both sides*, between its junction with Ferniehill Drive and its junction with Gilmerton Station Road; (ii)
 Ravenscroft Street, *both sides*, from the extended south-western kerbline of Drum Street, south-westwards for a distance of 50 metres or thereby; (iii) East Farm of Gilmerton, *both sides*, from the extended north-eastern kerbline of Drum Street, north-eastwards for a distance of 30 metres or thereby; (iv) Limefield, *both sides*, from the extended south-westwards for a distance of 30 metres or thereby; (iv) Drum Cottages, *both sides*, from the extended south-western kerbline of Drum Street, south-westwards for a distance of 30 metres or thereby; (vi)
 Candlemaker's Park, *both sides*, from the extended north-eastern kerbline of Drum Street, south-eastwards for a distance of 30 metres or thereby; (vii) Carter Drive, *both sides*, from the extended south-western kerbline of Drum Street, south-western kerbline of a distance of 30 metres or thereby; (vii) Carter Drive, both sides, from the extended south-western kerbline of Drum Street, south-westwards for a distance of 30 metres or thereby; and (viii) Newtoft Street, south-east side, between its junction with Hawthorn Place and its junction with Ravenscroft Place.
- Nothing in Article 3 shall apply to:
 (i) emergency service vehicles; or
 (ii) vehicles connected to the works.
- 5. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

6. The alternative route for through vehicular traffic in respect to the closures will be by way of: (i) Drum Street, East Farm of Gilmerton, Limefield, Drum Cottages and Candlemaker's Park – Newtoft Street, Gilmerton Dykes Street, Lasswade Road and Gilmerton Station Road; (ii) Ravenscroft Street - Newtoft Street and Ravenscroft Place; and (iii) Carter Drive -Gilmerton Station Road and Newbyth Road.
