THE CITY OF EDINBURGH COUNCIL (RANNOCH ROAD AREA) (NO. 2) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/109

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Rannoch Road Area) (No. 2) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Twenty-eighth day of June Two thousand and twenty-two up to and including the Thirtieth day of August Two thousand and twenty-two.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicles" means a vehicle being used for police, fire or ambulance purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; and "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate carriageway resurfacing works, no person shall (as signed as affected by the works):
 - (a) drive or cause or permit to be driven any vehicle on (i) **Rannoch Terrace**, in its entirety; (ii) **Rannoch Road**, between its junction with Drum Brae Drive and its junction with Alan Breck Gardens; and (iii) **Ransome Gardens**, at its junction with Rannoch Terrace; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i) **Rannoch Terrace**, in its entirety; (ii) **Rannoch Road**, between its junction with Drum Brae Drive and its junction with Alan Breck Gardens; (iii) **Ransome Gardens**, from the centre line of its junction with Rannoch Terrace, south-eastwards for a distance of 50 metres or thereby; (iv) **Rannoch Place**, from the centre line of its junction with Rannoch Road, northeastwards for a distance of 50 metres or thereby; (v) **Rannoch Grove**, from its junction with Rannoch Road, westwards for a distance of 50 metres; and (vi) **Hoseason Gardens**, from its junction with Rannoch Terrace, northwards and southwards for a distance of 30 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
- 5. The alternative route for through vehicular traffic in relation to the closures will be by way of: Drum Brae Drive, Hoseason Gardens and Alan Breck Gardens.
