THE CITY OF EDINBURGH COUNCIL (WESTBANK STREET AREA) (NO. 2) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/110

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Westbank Street Area) (No. 2) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Twenty-eighth day of June Two thousand and twenty-two up to and including the Thirtieth day of August Two thousand and twenty-two.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicles" means a vehicle being used for police, fire or ambulance purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; and "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate carriageway resurfacing works, no person shall (as signed as affected by the works):
 - (a) drive or cause or permit to be driven any vehicle on (i) **Westbank Street**, between its junction with Westbank Place and its junction with Portobello Promenade; (ii) **Hillcoat Place**, at its junction with Westbank Street; and (iii) **Great Cannon Bank**, at its junction with Westbank Street; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i) **Westbank Street**, in its entirety; (ii) **Hillcoat Place**, from the centre of its junction with Westbank Street, north-westwards for a distance of 30 metres or thereby; and (iii) **Great Cannon Bank**, from the centre of its junction with Westbank Street, north-westwards for a distance of 30 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
- 5. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' is hereby suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 6. The alternative route for through vehicular traffic in relation to the closures will be by way of: Hillcoat Place and Westbank Place.
