



THE CITY OF EDINBURGH COUNCIL (WARDIEBURN AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 – TEMP/22/151

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Granton Area) (Temporary Road Restriction and Traffic Regulation) Order 2022” and shall come into operation on the Eighteenth day of July Two thousand and twenty-two and shall remain in force up to and including the Thirtieth day of November Two thousand and twenty-two.
2. In this Order the following phrases have the meaning respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for police, fire or ambulance purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and
“Schedule” means a Schedule to this Order.
3. Save as provided in Article 4 of this Order, to facilitate CityFibre ducting works, (as signed as affected by the works), no person shall: -
 - (a) drive or cause or permit to be driven any vehicle on sections of the roads described in Schedule 1 of this Order, where closures will apply to roads in their entirety unless otherwise stated; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time (i) **Blackadder Place**; (ii) **Wardieburn Place South**; (iii) **Wardieburn Road**; (iv) **Wardieburn Street West**; and (v) **Wardieburn Terrace**, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
5. Whilst this Order remains in force, ‘The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018’ is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
6. Access for through vehicular traffic in respect to the closures will be by way of the roads outlined in Column 3 of Schedule 1 of this Order. Pedestrian access will be maintained.

ROAD CLOSURES

Wardieburn Place South	Between its junction with Wardieburn Terrace and its junction with Wardieburn Place East	Wardieburn Terrace, Wardieburn Street West & Wardieburn Place West
Wardieburn Place West/Wardieburn Place East	Between its junction with Pilton Drive North and its junction with Wardieburn Street East	Pilton Drive North, Boswall Parkway, Wardieburn Road, Wardieburn Street East & Wardieburn Terrace
Wardieburn Road	Between its junction with Wardieburn Place West and its junction with Boswall Parkway	Pilton Drive North, Boswall Parkway & Royston Mains Crescent
Wardieburn Street West	Between its junction with Wardieburn Place West and its junction with Wardieburn Terrace	Wardieburn Road, Wardieburn Place West & Wardieburn Terrace
Wardieburn Terrace	Between its junction with Wardieburn Road and its junction with Wardieburn Drive	Wardieburn Road, Wardieburn Place West & Wardieburn Drive
