THE CITY OF EDINBURGH COUNCIL (CCWEL SECTION 1 ROSEBURN STREET AREA)
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 -
TEMP/22/152

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (CCWEL Section 1 Roseburn Street Area) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Fifteenth day of July Two thousand and twenty-two up to and including the Twenty-third day of December Two thousand and twenty-two.
2. In this Order the following phrases have the meanings respectively assigned to them:
"Article" means an Article of this Order;
"emergency service vehicle" means a vehicle being used for ambulance, fire or police purposes;
"road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this order, includes part of a road;
"Schedule" means a Schedule to this Order; and
"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate public realm works, no person shall (as signed as affected by the works):
 - (a) drive or cause or permit any motor vehicle to enter or proceed into or on any length of (i) **Roseburn Gardens**, at its junction with Roseburn Terrace; and (ii) **Roseburn Place**, at its junction with Roseburn Street;
 - (b) drive or cause or permit any motor vehicle to be driven on (i) **Roseburn Street**, between its junction with Roseburn Terrace and its junction with Roseburn Place; and (ii) **Russell Road**, between its junction with Roseburn Street and its junction with Roseburn Maltings otherwise than in a North to South direction; or
 - (c) drive or cause or permit to be driven any vehicle on the road described in column 1 of Schedule 1 so as to make the prohibited turn specified in column 2 of Schedule 1, into the road specified in column 3 of Schedule 1 hereto.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
5. The alternative routes for through vehicular with respect to the prohibition of motor vehicles on **Roseburn Gardens** and **Roseburn Place** will be by way of Roseburn Gardens, Roseburn Place, Roseburn Drive, Roseburn Avenue and Roseburn Street.
6. The alternative routes for through vehicular traffic with respect to the one-way roads on (i) **Roseburn Street** and (ii) **Russell Road** will be by way of: (i) Roseburn Street, Westfield Road/Stevenson Road, Balgreen Road and A8; and (ii) Russell Road, Murieston Crescent, Gorgie Road, Balgreen Road and A8. Due to low level bridges, both diversion routes are not suitable for high-sided vehicles.

7. The alternative routes for through vehicular traffic with respect to the prohibited right turn from **Roseburn Terrace** into Roseburn Street will be by way of West Coates, Haymarket Terrace, Clifton Terrace, West Maitland Street, Torphichen Street and Morrison Street.
