
THE CITY OF EDINBURGH COUNCIL (CRAIGMILLAR PARK, MAYFIELD GARDENS & MINTO STREET) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/75

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984, as amended by the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Craigmillar Park, Mayfield Gardens & Minto Street) (Temporary Road Restriction and Traffic Regulation) Order 2022" and shall come into operation on the Twenty-fourth day of July Two thousand and twenty-two and shall remain in force up to and including the Twenty-first day of January Two thousand and twenty-three. The circumstances necessitating the restrictions within this Order, as stated in Article 2, will be subject to ongoing review and should it be determined that the restrictions are no longer required, then at that time the temporary restrictions shall be revoked by notice, under a separate Order.
2. Save as provided in Article 3 of this Order, to facilitate improved safety for pedestrians and cyclists during the current Covid-19 pandemic, supporting social distancing so that people can safely walk, wheel or cycle, no person shall, (as signed as affected by the works) except with the permission of a Parking Attendant, cause or permit any vehicle:-
 - (a) to wait, load onto or unload, at any time, on any part of the roads described in Schedule 1 to this order;
 - (b) to wait, at any time, or load onto and unload from any vehicle between the hours of 07:30 to 09:30 and 16:00 to 18:00, Monday to Friday, on any part of the roads described in Schedule 2 to this order; and
 - (c) to wait at any time on any part of Craigmillar Park, west side, from a point 93 metres or thereby north of the north kerblines of Wilton Road, northwards for a distance of 23 metres or thereby.
3. Nothing in
 - (a) Article 2 shall apply to vehicles being used in the service of the Police, Ambulance or Fire Service;
 - (b) Article 2(b) except between 07:30 to 09:30 hours and 16:00 to 18:30 hours, Monday to Friday and Article 2(c), shall apply so as to prevent any person from causing or permitting a vehicle to wait in any road described in said Article while the vehicle is in actual use for the purpose of delivering or collecting goods or while loading or unloading goods from or to premises adjoining the said road; provided that:
 - i. no such vehicle so engaged shall wait for a period of more than thirty minutes in the same place; and
 - ii. no such vehicle so engaged shall return to the same place, unless a period of more than thirty minutes has elapsed since the termination of the previous waiting period.
 - (c) Article 2(b) except between 07:30 to 09:30 hours and 16:00 to 18:30 hours of each day; and Article 2(c), shall apply to a vehicle displaying a valid disabled person's badge, provided that said vehicle is being used by, or for the conveyance of, the holder of a valid disabled person's badge.
4. The City of Edinburgh Council (A701, Newington Road to Straiton Road, Edinburgh) (Bus Priority Measures) Traffic Regulation Order 2003 will be suspended for the duration of this Order in relation to the following bus lanes:
 - i. Craigmillar Park any part of the west side of the road from a point 38 metres or thereby north of the north kerblines of Lygon Road, northwards to a point 40 metres or thereby north of the north kerblines of East Savile Road;
 - ii. Craigmillar Park any part of the west side of the road from a point 40 metres or thereby north of the north kerblines of East Savile Road, northwards to the north kerblines of Mentone Gardens;

- iii. Mayfield Gardens any part of the west side of the road from the north kerbline of Mentone Gardens, northwards to the north kerbline of Bright's Crescent;
 - iv. Minto Street any parts of the east side of the road from a point 12 metres or thereby south of the south kerbline of Salisbury Road, southwards to a point 34 metres or thereby north of the north kerbline of East Mayfield; and
 - v. Mayfield Gardens any part of the east side of the road from a point 10 metres or thereby south of the south kerbline of East Mayfield, southwards to the south kerbline of Peel Terrace.
5. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' will be suspended in so far as it is affected by the measures in Article 2 of this Order.

SCHEDULE 1 PROHIBITION OF WAITING, LOADING & UNLOADING AT ANY TIME

(1) **Mayfield Gardens:** (a) *west side:* (i) from a point 8 metres or thereby south of the extended southern kerbline of Bright's Crescent, southwards for a distance of 14 metres or thereby; (ii) from a point 5 metres or thereby north of the extended northern kerbline of Bright's Crescent, northwards for a distance of 30 metres or thereby; and (iii) from a point 13 metres or thereby south of the extended southern kerbline of West Mayfield, southwards for a distance of 13 metres or thereby; and (b) *east side:* (i) from a point 13 metres or thereby north of the extended northern kerbline of East Mayfield, northwards for a distance of 13 metres or thereby; (ii) from a point 13 metres or thereby south of the extended southern kerbline of East Mayfield, southwards for a distance of 13 metres or thereby; and (iii) from a point 15 metres or thereby north of the extended northern kerbline of Peel Terrace, northwards for a distance of 11 metres or thereby; (2) **Minto Street:** (a) *west side:* (i) from a point 14 metres or thereby north of the extended northern kerbline of West Mayfield, northwards for a distance of 13 metres or thereby; (ii) from a point 45 metres or thereby north of the extended northern kerbline of West Mayfield, northwards for a distance of 12 metres or thereby; and (iii) from a point 9 metres or thereby south of the extended southern kerbline of Salisbury Place, southwards for a distance of 16 metres or thereby; and (3) **Craigmillar Park:** (a) *east side:* (i) from a point 61 metres or thereby south of the extended southern kerbline of Ventnor Terrace, southwards for a distance of 11 metres or thereby; (ii) from a point 14 metres or thereby south of the extended southern kerbline of Crawford Road, southwards for a distance of 10 metres or thereby; (iii) from a point 11 metres or thereby north of the extended northern kerbline of East Suffolk Road, northwards for a distance of 29 metres or thereby; (iv) from a point 38 metres or thereby south of the extended southern kerbline of East Suffolk Road, southwards for a distance of 9 metres or thereby; (v) from a point 15 metres or thereby south of the extended southern kerbline of East Suffolk Road, southwards for a distance of 13 metres or thereby; and (vi) from a point 94 metres or thereby south of the extended southern kerbline of East Suffolk Road, southwards for a distance of 18 metres or thereby; and (b) *west side:* (i) from a point 42 metres or thereby north of the extended northern kerbline of Lygon Road, northwards for a distance of 40 metres or thereby; and (ii) from a point 6 metres or thereby north of the extended northern kerbline of Suffolk Road, northwards for a distance of 11 metres or thereby.

SCHEDULE 2

ROADS ON WHICH WAITING WILL BE RESTRICTED AT ALL TIMES AND LOADING AND UNLOADING WILL BE PROHIBITED DURING PEAK TIMES

(1) **Mayfield Gardens:** (a) *west side:* (i) from a point 40 metres or thereby north of the extended northern kerbline of East Savile Road, northwards for a distance of 10 metres or thereby; and (ii) from a point 14 metres or thereby north of the extended northern kerbline of Mentone Gardens, northwards for a distance of 137 metres or thereby; and (b) *east side,* from a point 26 metres or thereby south of the extended southern kerbline of East Mayfield, southwards for a distance of 69 metres; (2) **Minto Street:** (a) east side: (i) from a point 14 metres or thereby south of the extended southern kerbline of Salisbury Road, southwards for a distance of 19 metres or thereby; (ii) from a point 68 metres or thereby south of the extended southern kerbline of Salisbury Road, southwards for a distance of 112 metres or thereby; (iii) from a point 15 metres or thereby south of the extended southern kerbline of Blacket Avenue, southwards for a distance of 58 metres or thereby; (iv) from a point 15 metres or thereby north of the extended northern kerbline of Mayfield Terrace, northwards for a distance of 14 metres or thereby; and (v) from a point 15 metres or thereby south of the extended southern kerbline of Mayfield Terrace, southwards for a distance of 11 metres or thereby; and (3) **Craigmillar Park:** (a) *west side:* (i) from a point 13 metres or thereby north of the extended northern kerbline of Wilton Road, northwards for a distance of 80 metres or thereby; (ii) from a point 86 metres or thereby south of the extended southern kerbline of Suffolk Road, northwards for a distance of 47 metres or thereby; and (iii) from a point 17 metres or thereby north of the extended northern kerbline of Suffolk Road, northwards for a distance of 87 metres or thereby.
