## THE CITY OF EDINBURGH COUNCIL (TELFORD ROAD AREA) (NO. 2) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 – TEMP/22/87

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Telford Road Area) (No. 2) (Temporary Road Restriction and Traffic Regulation) Order 2022" and shall come into operation on the First day of August Two thousand and twenty-two and shall remain in force up to and including the Thirty-first day of October Two thousand and twenty-two.
- In this Order the following phrases have the meaning respectively assigned to them: "Article" means an Article of this Order; "emergency service vehicles" means a vehicle being used for police, fire or ambulance purposes;

"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "Schedule" means a Schedule to this Order.

- 3. Save as provided in Article 4 of this Order, to facilitate signal replacement, carriageway resurfacing and refuge island upgrade works, no person shall (as signed as affected by the works): -
  - (a) drive or cause or permit to be driven any vehicle on (i) Groathill Avenue, at its junction with Telford Road; (ii) Telford Drive, at its junction with Telford Road; and (iii) Telford Road: (1) at the access to the Western General Hospital; (2) at its access to The Scottish Engineer; (3) at the entry and exit to McDonalds; and (4) at the entry and exit to Nos. 78-89 Telford Road;
  - (b) except with the permission of a Parking Attendant, no person shall cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i) **Telford Road**, between its junction with Telford Place and its junction with Groathill Road South; (ii) **Groathill Avenue**, from the extended south-eastern kerbline of Telford Road, south-westwards for a distance of 70 metres or thereby; (iii) **Telford Drive**, from the extended north-western kerbline of Telford Road, northwestwards for a distance of 40 metres or thereby; and (iv) **Telford Road**, from the extended north-eastern kerbline of Telford Drive, north-eastwards to the access of No. 107 Telford Road; or
  - (c) drive or cause or permit to be driven any vehicle on the road described in column 1 so as to make the prohibited turn specified in column 2, into the road specified in column 3 of Schedule 1.
- 4. Nothing in Article 3 shall apply to:
  - (i) emergency service vehicles; or
  - (ii) vehicles connected to the works.
- 5. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

6. The alternative route for through vehicular traffic in respect of the closures will be by way of
(i) Groathill Avenue – South Groathill Avenue, Queensferry Road, Hillview, Hillhouse Road and Telford Road; and (ii) Telford Drive - Telford Place (*or Telford Gardens*).
