
THE CITY OF EDINBURGH COUNCIL (ROYAL EDINBURGH MILITARY TATTOO) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/156

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Royal Edinburgh Military Tattoo) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Third day of August Two thousand and twenty-two up to and including the Twenty-seventh day of August Two thousand and twenty-two, during the hours specified in the Schedules to this Order.
2. In this Order the following phrases have the meanings respectively assigned to them:
 - "Article" means an Article of this Order;
 - "authorised vehicles" means any vehicle that can, upon request, provide a valid accredited pass authorised by the City of Edinburgh Council and is associated with the Royal Edinburgh Military Tattoo events for the duration of this Order;
 - "emergency service vehicle" means a vehicle being used for police, fire or ambulance purposes;
 - "events related vehicles" means any vehicle authorised by City of Edinburgh Council as being connected with the event, and for the purposes of this Order, includes event related coaches/buses;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
 - "pass" means an official pass issued by the City of Edinburgh Council's representatives for the purpose of this Order;
 - "pedal cycle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;
 - "Schedule" means a Schedule to this Order;
 - "taxi" has the same meaning as in Section 23 of the Civic Government (Scotland) Act 1982;
 - and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate the safe passage of pedestrian traffic, secure access to Edinburgh Castle in the event of an emergency and ensure the public safety of spectators entering and leaving Edinburgh Castle Esplanade and the dispersal of participants in the Royal Edinburgh Military Tattoo, no person shall (as signed as affected by the events):
 - (a) drive or cause or permit to be driven any vehicle on the sections of roads specified in Schedule 1 hereto, during the hours and on the dates specified in the said Schedule, where closures will apply to the entire road unless otherwise stated;
 - (b) walk or cause or permit any person to walk on the entire length of **Castle Wynd North**, where restrictions will apply during the hours and on the dates specified in Schedule 2 hereto, as signed; and
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads specified in Schedule 3 hereto, during the hours and on the dates specified in the said Schedule, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.

4. Nothing in:
- (i) Article 3 shall apply to emergency services vehicles;
 - (ii) Article 3(a) shall apply to official vehicles associated with the event (*including staff from the Castle as agreed*);
 - (iii) Article 3(a) shall apply to residents of, and bona fide visitors to **Mound Place, North Bank Street, Ramsay Lane, Ramsay Garden, Lawnmarket and Upper Bow**;
 - (iv) Article 3(a) shall apply to pedal cycles on the section of **King's Stables Road** described in Schedule 1 hereto;
 - (v) Article 3(b) shall apply to residents of, and bona fide visitors displaying an accredited Tattoo pass on the section of **Castle Wynd North** described in Schedule 2 hereto;
 - (vi) Article 3(a) and (c) shall apply to authorised vehicles displaying an accredited Tattoo pass on the sections of **Castlehill, Johnston Terrace and St Giles' Street** described in Schedules 1 & 3 hereto; and
 - (vii) Articles 3(a) and (c) shall apply to event related vehicles displaying an accredited Tattoo pass on the sections of **Lauriston Place, Castle Terrace, Spittal Street and King's Stables Road** described in Schedules 1 & 3 to this Order.
 - (viii) Article 3(c) shall apply to taxis on the section of **George IV Bridge** described in Schedule 3 to this Order.
5. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018' is hereby suspended in so far as it is affected by the restrictions specified in Schedule 3 of this Order.
6. Pedestrian traffic and access will be maintained for residents and bona fide visitors, as will access for emergency vehicles.
7. The alternative routes for through vehicular traffic will be by way of Castle Terrace, Lady Lawson Street, Lauriston Place, Forrest Road, Bristo Place, Teviot Place and George IV Bridge.

SCHEDULE 1 ROAD CLOSURES

From 18:00 hours to 23:00 hours on 03/08/2022; and
From 16:30 hours to 23:59 hours DAILY from 04/08/2022 to 27/08/2022 on:

Castlehill (except vehicles displaying an accredited Tattoo pass).

From 17:00 hours to 23:59 hours (**weekdays only**) from 03/08/2022 to 25/08/2022; and
From 16:00 hours to 23:59 hours on 06/08/2022, 13/08/2022, 20/08/2022, 26/08/2022 and
27/08/2022 on:

(i) **Mound Place**; (ii) **Ramsay Lane**; (iii) **Ramsay Garden**; (iv) **Johnston Terrace**; (v)
Lawnmarket, between its junction with Castlehill and its junction with George IV Bridge; (vi)
Upper Bow; and (vii) **Castle Wynd North**.

From 18:30 hours to 19:30 hours (**weekdays only**) from 05/08/2022 to 25/08/2022 on:

St Giles Street, from its junction with North Bank Street, eastwards for a distance of 30 metres or
thereby (except vehicles displaying an accredited Tattoo pass).

From 22:00 hours to 23:00 hours (**weekdays only**) from 05/08/2022 to 25/08/2022 on:

St Giles Street in its entirety (except vehicles displaying an accredited Tattoo pass).

From 08:00 hours to 20:00 hours on 03/08/22;
From 08:00 hours to 23:59 hours DAILY from 04/08/22 to 07/08/22 and 15/08/22 to 20/08/22;
From 07:00 hours on 08/08/22 to 03:00 hours on 09/08/22; from 07:00 hours on 09/08/22 to 03:00
hours on 10/08/22; from 07:00 hours on 10/08/22 to 03:00 hours on 11/08/22; from 07:00 hours on
11/08/22 to 03:00 hours on 12/08/22; from 07:00 hours on 12/08/22 to 03:00 hours on 13/08/22;
from 07:00 hours on 13/08/22 to 03:00 hours on 14/08/22; from 07:00 hours on 14/08/22 to 03:00
hours on 15/08/22;
From 19:00 hours to 23:59 hours DAILY from 22/08/22 to 25/08/22 and
From 16:15 hours to 23:59 hours on 26/08/22 & 27/08/22 on:

King's Stables Road (except event related vehicles displaying an accredited Tattoo pass (or Summer
Sessions pass), and pedal cycles).

SCHEDULE 2 PEDESTRIAN CLOSURE

From 17:00 hours to 23:59 hours (**weekdays only**) from 03/08/2022 to 25/08/2022; and
From 16:00 hours to 23:59 hours on 06/08/2022, 13/08/2022, 20/08/2022, 26/08/2022 and
27/08/2022 on:

Castle Wynd North (except residents and bona fide visitors).

SCHEDULE 3
PROHIBITION OF WAITING, LOADING & UNLOADING

From 15:00 hours to 23:59 hours (weekdays only) & 13:00 hours to 23:59 hours (Saturdays) from 03/08/2022 to 27/08/2022 on:

(i) **Castlehill** (except authorised vehicles displaying the appropriate accredited pass); and (ii) **Lauriston Place, both sides**, between its junction with Forrest Road and its junction with Keir Street (except event related coaches displaying the appropriate accredited pass on the **North side**).

From 14:00 hours to 23:59 hours (weekdays only) & 13:00 hours to 23:59 hours (Saturdays) from 03/08/2022 to 27/08/2022 on:

(i) **Lawnmarket, both sides**, between its junction with Castlehill and its junction with George IV Bridge; (ii) **Johnston Terrace** (except authorised vehicles displaying the appropriate accredited pass); (iii) **Mound Place**: (a) **north side**, in its entirety (except residents and bona fide visitors); and (b) **south side**, from its junction with Ramsay Lane, eastwards to a point 21 metres or thereby west of its junction with North Bank Street (except residents and bona fide visitors); (iv) **Candlemaker Row**; (v) **Ramsay Lane**; (vi) **Castle Terrace, south side**, from its junction with Lothian Road, south-eastwards for a distance of 87 metres or thereby; (vii) **Grassmarket**, main carriageway in its entirety (except recessed parking bays); (viii) **Upper Bow**, all sides in its entirety (except residents and bona fide visitors); (ix) **Castle Terrace, both sides**, from its junction with Cambridge Street, south-eastwards for a distance of 172 metres or thereby (except event related coaches displaying the appropriate accredited pass); (x) **Spittal Street, both sides**, from a point 53 metres or thereby north-east of the extended northern kerbline of Bread Street, north-eastwards for a distance of 68 metres or thereby (except event related coaches displaying the appropriate accredited pass); and (xi) **George IV Bridge** (except the extended taxi rank on the **east side** and emergency service vehicles).

From 00:01 hours on 03/08/2022 to 23:59 hours on 09/08/2022; and
From 00:01 hours on 17/08/2022 to 23:59 hours on 21/08/2022 on:

Johnston Terrace, north side, from the start of the coach parking, eastwards for a distance of 90 metres or thereby (except authorised event related vehicles displaying the appropriate accredited pass).

From 00:01 hours on 03/08/2022 to 23:59 hours on 09/08/2022 on:

Johnston Terrace, north side, from the start of the residents parking bays, westwards for a distance of 14 metres or thereby (except authorised event related vehicles displaying the appropriate accredited pass).

From 00:01 hours on 03/08/2022 to 23:59 hours on 20/08/2022 on:

King's Stables Road, both sides, from its junction with Lothian Road, south-eastwards for a distance of 250 metres or thereby (except event related vehicles displaying the appropriate accredited pass).

From 16:00 hours to 23:59 hours (weekdays only) & from 13:15 hours to 23:59 hours (Saturdays) from 04/08/2022 to 20/08/2022 on:

King's Stables Road, both sides, from a point 250 metres or thereby south-east of its junction with Lothian Road, south-eastwards to its junction with Grassmarket (except event related coaches displaying the appropriate accredited pass).

From 16:00 hours to 23:59 hours DAILY from 22/08/2022 to 25/08/2022 & from 13:15 hours to 23:59 hours on 26/08/2022 & 27/08/2022 on:

King's Stables Road, both sides, in its entirety (*except event related coaches displaying the appropriate accredited pass*).

From 12:00 hours to 23:59 hours (Saturdays) from 06/08/2022 to 27/08/2022 on:

West Port (*except recessed bays*).

From 15:15 hours to 23:00 hours (weekdays only) from 05/08/2022 to 25/08/2022 on:

St Giles' Street, both sides, from its junction with North Bank Street, eastwards for a distance of 30 metres or thereby (*except authorised vehicles displaying the appropriate accredited pass*).

From 17:00 hours on 03/08/2022 to 23:59 hours on 27/08/2022 on:

Colinton Road, south side, from its junction with Oxfangs Road North, south-westwards for a distance of 590 metres or thereby.
