THE CITY OF EDINBURGH COUNCIL (RIDING OF THE MARCHES) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/174

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers being satisfied that traffic on the lengths of roads specified in the Schedules hereto should be prohibited or restricted to facilitate public safety during the Riding of the Marches event, and to enable members of the public to watch this event and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, with the consent of the Scottish Ministers under section 16B(1)(b) and 16B(6)(b) of the said Act, hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Riding of the Marches) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect during the hours and on the dates specified in the Schedules to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicles" means a vehicle being used for ambulance, fire or police purposes;
 - "events vehicles" means any vehicle authorised by City of Edinburgh Council as being connected with the event:
 - "Parking Attendant" has the same meaning as in Section 63A of the Roads (Scotland) Act 1984;
 - "road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and for the avoidance of doubt, for the purposes of this order, includes part of a road
 - "Schedule" means a Schedule to this Order;
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4 of this Order, to facilitate public safety during the Riding of the Marches event, no person shall (as signed as affected by the event): -
 - (a) drive or cause or permit to be driven any vehicle on the sections of roads described during the hours and on the date specified in Schedule 1 hereto, where closures will apply to the entire road unless otherwise stated; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the parts of the roads during the hours and on the dates described in Schedule 2 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
- 4. Nothing in:
 - (i) Article 3 shall apply to emergency service vehicles;
 - (ii) Article 3(a) shall apply to event vehicles on the sections of roads specified in Schedule 1, during the hours specified in the said Schedule; and
 - (iii) Article 3(b) shall apply to event vehicles on the sections of **King's Stables Road**, **Johnston Terrace**, **High Street**, **West Parliament Square**, **Parliament Square** and **St Giles' Street** described in Schedule 2 to this Order.

- 5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
- 6. "The City of Edinburgh Council (Cockburn Street Area) (No. 2) (Temporary Road Restriction and Traffic Regulation) Order 2022" will be suspended *between 10:30 hours and 18:00 hours on 11/09/2022* in relation to the *prohibition of motor vehicles* on **High Street** at its junction with Cockburn Street, to facilitate the implementation of barriers to assist public safety during the event.
- 7. "The City of Edinburgh Council (Fly Music Festival) (Temporary Road Restriction and Traffic Regulation) Order 2022" will be suspended between 06:00 hours and 18:00 hours on 11/09/2022 in relation to the road closure and waiting, loading and unloading prohibitions on the section of King's Stables Road (except exemptions contained in said Order), to facilitate events vehicles.
- 8. The alternative routes for through vehicular traffic will be by way of: Calton Road, Leith Street, Princes Street, North Bridge, South Bridge, Blair Street, Cowgate, St Mary's Street & Jeffrey Street. Pedestrian access will be maintained.

SCHEDULE 1 ROAD CLOSURES

From 09:00 hours to 12:15 hours on 11/09/2022:

(i) **Gilmerton Road**, between its junction with the roundabout at the City Bypass and its junction with Gilmerton Station Road; (ii) **Gilmerton Station Road**; (iii) **Lasswade Road**, between its junction with Gilmerton Station Road and its junction with Captain's Road; (iv) **Captain's Road**; (v) **Howden Hall Road**, *northbound*, between its junction with Captain's Road and its junction with Alnwickhill Road; (vi) **Alnwickhill Road**, between its junction with Howden Hall Road and its junction with Stanedykehead; (vii) **Stanedykehead**; (viii) **Mounthooly Loan**, between its junction with Frogston Road West and its junction with Galachlawside; (ix) **Frogston Road West**, between its junction with Winton Drive and its junction with Frogston Brae; (x) **Frogston Brae**; (xi) **Frogston Road East**; (xii) **Burdiehouse Road**, *southbound*, in its entirety; and (xiii) **Lang Loan**.

From 10:30 hours to 18:00 hours on 11/09/2022:

(i) **High Street**, from a point 10 metres or thereby east of the extended eastern kerbline of the vehicular access to Parliament Square, westwards to Lawnmarket; (ii) **Lawnmarket**, between its junction with High Street and its junction with George IV Bridge; (iii) **West Parliament Square**; (iv) **Parliament Square**; and (v) **St Giles' Street**.

From 14:00 hours to 16:00 hours on 11/09/2022:

(i) **Old Dalkeith Road**: (a) *northbound*, between its junction with The Wisp and its junction with Ferniehill Road; and (b) between its junction with Moredunvale Road and its junction with Craigmillar Castle Road; (ii) **Ferniehill Road**, between its junction with Old Dalkeith Road and its junction with Moredun Park Road; (iii) **Moredun Park Road**, between its junction with Ferniehill Road and its junction with Craigour Avenue; (iv) **Craigour Avenue**; (v) **Craigour Drive**, between its junction with Craigour Avenue and its junction with Moredunvale Road; (vi) **Moredunvale Road**, between its junction with Craigour Drive and its junction with Old Dalkeith Road; (vii) **Craigmillar Castle Road**; (viii) **Castlebrae Avenue**, between its junction with Castlebrae Wynd and its junction with Craigmillar Castle Road; (ix) **Duddingston Road West**, between its junction with Niddrie Mains Road and its junction with Old Church Lane; and (x) **Old Church Lane**.

From 14:30 hours to 18:00 hours on 11/09/2022:

(i) Queen's Drive; (ii) Horse Wynd; (iii) Canongate; (iv) Cranston Street; (v) Galloway's Entry; (vi) Brown's Close; (vii) Reid's Court; (viii) Dunbar's Close; (ix) Sugarhouse Close; (x) Gladstone Court/Bowling Green Court; (xi) New Street, between its junction with East Market Street and its junction with Canongate; (xii) Lawnmarket, between its junction with George IV Bridge and its junction with Johnston Terrace; (xiii) Johnston Terrace; (xiv) Castle Terrace, between its junction with Johnston Terrace and its junction with Lady Lawson Street; (xv) Lady Lawson Street, between its junction with Castle Terrace and its junction with West Port; (xvi) West Port, between its junction with Lady Lawson Street and its junction with King's Stables Road; and (xvii) South Bridge, northbound, between its junction with Blair Street and its junction with North Bridge.

From 12:30 hours to 18:00 hours on 11/09/2022:

(i) King's Stables Road; (ii) Lady Wynd; and (iii) King's Stables Lane.

SCHEDULE 2 PROHIBITION OF WAITING, LOADING & UNLOADING

From 09:00 hours on 09/09/2022 to 10:29 hours on 11/09/2022 and from 18:01 hours on 11/09/2022 to 16:00 hours on 12/09/2022:

Parliament Square, *east side*, from the northernmost extent of the steps to St Giles' Cathedral, northwards to the southernmost extent of the disabled bays.

From 06:00 hours to 18:00 hours on 11/09/2022:

(i) **King's Stables Road** (except events vehicles); (ii) **Johnston Terrace**, north side, from the westernmost extent of Castle Wynd North steps, eastwards for a distance of 62 metres or thereby (except event vehicles); (iii) **West Port** (except recessed bays); and (iv) **East Fountainbridge** (except recessed bays).

From 10:30 hours to 18:00 hours on 11/09/2022:

(i) **Lawnmarket**, *both sides*, between its junction with George IV Bridge and its junction with High Street; (ii) **High Street**, *both sides*, from a point 10 metres or thereby east of the extended eastern kerbline of the vehicular access to Parliament Square, westwards to Lawnmarket (*except events vehicles*); (iii) **West Parliament Square** (*except events vehicles*); (iv) **Parliament Square** (*except events vehicles*); and (v) **St Giles' Street** (*except events vehicles*).

From 11:30 hours to 18:00 hours on 11/09/2022:

(i) **Lawnmarket**, *both sides*, between its junction with Johnston Terrace and its junction with George IV Bridge; (ii) **High Street**, *both sides*, between its junction with South Bridge and its junction with Canongate; (iii) **Canongate**; (iv) **Abbey Strand**; (v) **Calton Road**, *both sides*, from its junction with Abbeyhill, westwards for a distance of 50 metres or thereby; (vi) **Horse Wynd**; (vii) **Queen's Drive**, *both sides*, between its junction with Holyrood Gait and its junction with Horse Wynd; and (viii) **Lady Lawson Street**, *north-east side*, between its junction with Spittal Street and its junction with West Port.

From 13:00 hours to 16:00 hours on 11/09/2022:

Old Church Lane.
