## THE ROAD TRAFFIC REGULATION ACT 1984: SECTION 14 EVENTS RELATING TO THE PASSING OF HER MAJESTY THE QUEEN, EDINBURGH

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14(2) of the Road Traffic Regulation Act 1984, as amended, that for the reason set out in Section 14(1)(b), being satisfied that traffic on the road on which this Notice has been placed, should be prohibited or restricted to facilitate the mourning of the death of her majesty The Queen, to enable members of the public to attend and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Notice.

- 1. This Notice shall come into effect on the day Buckingham Palace announces the death of Her Majesty, The Queen, for a period of up to fourteen days after the aforementioned day.
- 2. Save as provided in Article 3 of this Notice, in order to facilitate the placing and removal of cones, signs and barriers and to facilitate public safety, the use of the road on which this Notice has been placed shall be prohibited, restricted or regulated from time to time by one or more of the measures specified in the Schedule attached hereto, all as signed on street as required.
- 3. Nothing in Article 2 of this Notice shall apply to any vehicle being used with the permission or at the direction of a police constable in uniform.
- 4. The alternative routes for through vehicular traffic are available by way of: North Route (*i*) Telford Road, Ferry Road, North Junction Street, A199, A1 & A720; and South Routes; (*i*) Glasgow Road (A8), M9, M8, A720, Calder Road (A71), Stenhouse Road & Gorgie Road; (*ii*) A702, Biggar Road, Buckstone Terrace, Pentland Terrace, Greenbank Terrace, Comiston Road & Morningside Road; (*iii*) A1, Milton Road, Duddingston Crescent, Milton Road West, Willowbrae Road & London Road; and (*iv*) A7, Old Dalkeith Road & Dalkeith Road, as signed. Access for emergency vehicles will be maintained. Pedestrian traffic and access will be maintained.
- 5. The restrictions imposed by Article 2 in this Notice shall repeal any existing provision, restriction or requirement imposed by any regulations made or having effect as if made under the 1984 Act as amended as aforesaid or by or under any other enactment, whilst the provisions of this Notice are in operation in accordance with Article 1 of this Notice.
