
THE CITY OF EDINBURGH COUNCIL (NEWHAVEN AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 - TEMP/22/113

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Newhaven Area) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Nineteenth day of September Two thousand and twenty-two up to and including the Twentieth day of January Two thousand and twenty-three.
2. In this Order the following phrases have the meanings respectively assigned to them:
 - “Article” means an Article of this Order;
 - “emergency service vehicles” means a vehicle being used for police, fire or ambulance purposes;
 - “Parking Attendant” has the same meaning as in Section 63A of the Roads (Scotland) Act 1984;
 - “Schedule” means a Schedule to this Order; and
 - “vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate public realm works, no person shall (as signed as affected by the works):
 - (a) drive or cause or permit to be driven any vehicle on the sections of road described in Schedule 1 hereto;
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on (i) **Newhaven Road, both sides**, from a point 50 metres or thereby south of its junction with Stanley Road to a point 10 metres or thereby north of its junction with Park Road; (ii) **Stanley Road, both sides**, between its junction with Newhaven Road and its junction with West Cherrybank; (iii) **Park Road**; and (iv) **Derby Street**, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
5. ‘The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018’ is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

6. The alternative routes for through vehicular traffic in relation to the closures will be by way of (i) **Newhaven Road**: (1) and (3) – Ferry Road, Craighall Road and Stanley Road; and (2) – Stanley Road, Craighall Road and Lindsay Road; (ii) **Stanley Road** – Newhaven Road, Ferry Road and Craighall Road; (iii) **Park Road** – Newhaven Road and Stanley Road; (iv) **Derby Street** – Newhaven Road and Stanley Road; (v) **Jessfield Terrace** – Hawthornvale and Newhaven Road; and (vi) **Hawthornvale** – Newhaven Road and Jessfield Terrace. The following roads have no available diversion where access will be maintained: (vii) **Park Place**; (viii) **Belvedere Park**; and (ix) **West Cherrybank**.

SCHEDULE 1 ROAD CLOSURES

(i) **Newhaven Road**: (1) from a point 50 metres or thereby south of its junction with Stanley Road to its junction with Hawthornvale; (2) between its junction with Hawthornvale and its junction with Jessfield Terrace; and (3) from its junction with Jessfield Terrace to a point 10 metres or thereby north of its junction with Park Road; (ii) **Stanley Road**: (1) between its junction with Newhaven Road and its junction with Derby Street; (2) between its junction with Derby Street and its junction with Park Road; and (3) between its junction with Park Road and its junction with West Cherrybank; (iii) **Park Road**: (1) *east-west leg*, from its junction with Newhaven Road to the westernmost point of its east-west leg; and (2) *north-south leg*, from its junction with Stanley Road to the junction with its east-west leg; (iv) **Derby Street**, in its entirety; (v) **Jessfield Terrace**, at its junction with Newhaven Road; (vi) **Hawthornvale**, at its junction with Newhaven Road; (vii) **Park Place**, at its junction with Park Road; (viii) **Belvedere Park**, at its junction with Park Road; and (ix) **West Cherrybank**, at its junction with Stanley Road.
