THE CITY OF EDINBURGH COUNCIL (MYRESIDE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 – TEMP/22/188

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -


1. This Order may be cited as “The City of Edinburgh Council (Myreside Area) (Temporary Road Restriction and Traffic Regulation) Order 2022” and shall come into operation on the Thirty-first day of October Two thousand and twenty-two and shall remain in force up to and including the Eighth day of January Two thousand and twenty-three.
2. In this Order the following phrases have the meaning respectively assigned to them:  
“Article” means an Article of this Order;  
“emergency service vehicles” means a vehicle being used for police, fire or ambulance purposes;  
“Parking Attendant” has the same meaning as in Section 63A of the Roads (Scotland) Act 1984;  
“Schedule” means a Schedule to this Order;  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and  
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
3. Save as provided in Article 4 of this Order, to facilitate CityFibre ducting works, no person shall (as signed as affected by the works): -
  - (a) drive or cause or permit to be driven any vehicle on: (i) **Myreside View**, at its junction with Colinton Road; (ii) **Merchiston Gardens**, between its junction with South Gillsland Road and its junction with Colinton Road; and (iii) **Mid Gillsland Road**, between its junction with Colinton Road and its junction with Spylaw Road; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on: (i) **Myreside Road**; (ii) **Myreside View**; (iii) **Polwarth Grove**; (iv) **Polwarth Terrace**; (v) **South Gillsland Road**; (vi) **Spylaw Road**; (vii) **Colinton Road, both sides**, between its junction with Polwarth Terrace and its junction with South Ettrick Road; (viii) **Gillsland Road**; (ix) **Gray’s Loan**; (x) **Merchiston Gardens**; and (xi) **Mid Gillsland Road**, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

6. The alternative routes for through vehicular traffic in respect of the closures will be by way of (i) **Myreside View** – no diversion available, access maintained; (ii) **Merchiston Gardens** – South Gillsland Road and Colinton Road; and (iii) **Mid Gillsland Road** – Colinton Road, Gray’s Loan and Spylaw Road.
