THE CITY OF EDINBURGH COUNCIL (COLINTON MAINS ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 – TEMP/22/157

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Colinton Mains Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2022” and shall come into operation on the Twenty-first day of November Two thousand and twenty-two and shall remain in force up to and including the Sixth day of November Two thousand and twenty-three.
2. In this Order the following phrases have the meaning respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for police, fire or ambulance purposes;
“Parking Attendant” has the same meaning as in Section 63A of the Roads (Scotland) Act 1984;
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
3. Save as provided in Article 4 of this Order, to facilitate public realm works (as signed as affected by the works), no person shall:
 - (a) drive or cause or permit to be driven any vehicle on **Colinton Mains Road**, between its junction with Colinton Mains Drive and its easternmost junction with Oxgangs Terrace; and
 - (b) except with the permission of a Parking Attendant, no person shall cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on:
 - (i) **Colinton Mains Road, both sides**, between its junction with Colinton Mains Drive and its easternmost junction with Oxgangs Terrace; (ii) **Colinton Mains Drive, south side**, from the centre of its junction with Colinton Mains Road, eastwards and westwards for a distance of 20 metres or thereby; (iii) **Colinton Mains Crescent, both sides**, from the centre of its junction with Colinton Mains Road, eastwards for a distance of 50 metres or thereby; & (iv) **Oxgangs Terrace, both sides**: (1) from the centre of its westernmost junction with Colinton Mains Road, eastwards for a distance of 50 metres or thereby; & (2) from the centre of its easternmost junction with Colinton Mains Road, eastwards and westwards for a distance of 40 metres or thereby.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

6. The alternative route for through vehicular traffic in respect of the closure of Colinton Mains Road is by Colinton Mains Drive and Oxfangs Terrace.
