THE CITY OF EDINBURGH COUNCIL (NEWBATTLE TERRACE AREA) (NO. 2)
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2022 -
TEMP/22/201

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Newbattle Terrace Area) (No. 2) (Temporary Road Restriction and Traffic Regulation) Order 2022". The Order shall have effect from the Twenty-eighth day of November Two thousand and twenty-two up to and including the Thirty-first day of December Two thousand and twenty-two.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
"road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this order, includes part of a road;
"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
3. Save as provided in Article 4, to facilitate public realm works (as signed as affected by the works), no person shall:
 - (a) drive or cause or permit to be driven any vehicle on (i) **Newbattle Terrace**: (1) between its junction with Morningside Road and its junction with Falcon Gardens; and (2) between its junction with Pitsligo Road and its junction with Canaan Lane; (ii) **Eden Lane**, at its junction with Newbattle Terrace; and (iii) **Woodcroft Road**, at its junction with Newbattle Terrace (*at rear private car park entrance/exit*); and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of **Newbattle Terrace**: (1) between its junction with Morningside Road and its junction with Falcon Gardens; and (2) between its junction with Pitsligo Road and its junction with Canaan Lane.
4. Nothing in Article 3 shall apply to emergency service vehicles or any vehicles connected to the works.
5. The 2018 Order 2018 will be suspended in so far as it is affected by the measures outlined in Article 3(b) of this Order.

6. The alternative routes for through vehicular traffic in respect of the closures will be by way of: (i) **Newbattle Terrace**: (1) Morningside Road, Church Hill Place, Church Hill & Pitsligo Road; & (2) Pitsligo Road, Church Hill, Strathearn Place, Strathearn Road, Kilgraston Road & Whitehouse Terrace. The following roads have no diversion, where access will be maintained: (ii) **Eden Lane**; & (iii) **Woodcroft Road**.
