THE CITY OF EDINBURGH COUNCIL (BANKHEAD CROSSWAY NORTH & BANKHEAD AVENUE) (TEMPORARY ROAD AND RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/15

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- This Order may be cited as "The City of Edinburgh Council (Bankhead Crossway North & Bankhead Avenue) (Temporary Road Restriction and Traffic Regulation) Order 2023" and shall come into operation on the Sixth day of February Two Thousand and twenty-three and shall remain in force up to and including the Fourteenth day of March Two thousand and twenty-three.
- 2. In this Order the following phrases have the meaning respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for police, fire, or ambulance purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4 of this Order, to facilitate the installation of new LV ducting and cables (as signed as affected by the works), no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i) **Bankhead Crossway North**, from a point 50 metres or thereby south-west of the extended south-western kerbline of Bankhead Avenue (*southern section*), north-eastwards to a point 50 metres or thereby north-east of the extended north-eastern kerbline of Bankhead Avenue (*southern section*); and (ii) **Bankhead Avenue** (*southern section*), from a point 5 metres or thereby south-east of the extended south-eastern kerbline of Bankhead Crossway North, south-eastwards to a point 20 metres or thereby north-west of the extended north-western kerbline of Bankhead Loan.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3 of this Order.
