
THE CITY OF EDINBURGH COUNCIL (COMISTON AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/20

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Comiston Area) (Temporary Road Restriction and Traffic Regulation) Order 2023” and shall come into operation on the Sixth day of February Two thousand and twenty-three and shall remain in force up to and including the Seventh day of April Two thousand and twenty-three.
2. In this Order the following phrases have the meaning respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for police, fire or ambulance purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
3. Save as provided in Article 4 of this Order, to facilitate CityFibre ducting works (as signed as affected by the works), no person shall:
 - (a) drive or cause or permit to be driven any vehicle on the sections of roads described in Schedule 1 hereto; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads described in Schedule 2 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
6. The alternative routes for through vehicular traffic in respect of the closures will be by way of:
 - (i) **Comiston Drive** – St Ronan’s Terrace, Craiglea Drive and Morningside Grove;
 - (iii) **Craiglea Drive** – St Ronan’s Terrace, Morningside Drive and Morningside Grove;
 - (v) **Dalhousie Terrace** – Comiston Drive; St Ronan’s Terrace and Morningside Drive;
 - (vi) **St Clair Terrace** – Comiston Drive, Morningside Grove and Morningside Drive;
 - (vii) **St Fillan’s Terrace** – Comiston Drive, St Ninian’s Terrace and Morningside Drive;
 - (viii) **St Ninian’s Terrace** – Comiston Drive, St Clair Terrace and Morningside Drive;
 - (ix) **St Ronan’s Terrace** – Comiston Drive, St Fillan’s Terrace and Morningside Drive;
 - (xi) **Comiston Place** – Comiston Road, Comiston Terrace and Braid Road; and
 - (xii) **Ethel Terrace** – Morningside Drive, Dalhousie Terrace and Craiglea Drive.

7. The following roads have no available diversions, where access will be maintained: (ii) **Craighill Gardens**; (iv) **Craiglea Place**; and (x) **Comiston Gardens**.

SCHEDULE 1 ROAD CLOSURES

(i) **Comiston Drive**, between its junction with St Ronan's Terrace and its junction with Morningside Grove; (ii) **Craighill Gardens**, in its entirety; (iii) **Craiglea Drive**, between its junction with St Ronan's Terrace and its junction with Morningside Grove; (iv) **Craiglea Place**, in its entirety; (v) **Dalhousie Terrace**, between its junction with Comiston Drive and its junction with Morningside Drive; (vi) **St Clair Terrace**, between its junction with Comiston Drive and its junction with Morningside Drive; (vii) **St Fillan's Terrace**, between its junction with Comiston Drive and its junction with Morningside Drive; (viii) **St Ninian's Terrace**, between its junction with Comiston Drive and its junction with Morningside Drive; (ix) **St Ronan's Terrace**, between its junction with Comiston Drive and its junction with Morningside Drive; (x) **Comiston Gardens**, in its entirety; (xi) **Comiston Place**, between its junction with Comiston Road and its junction with Braid Road; and (xii) **Ethel Terrace**, between its junction with Craiglea Drive and its junction with Morningside Drive.

SCHEDULE 2 PROHIBITION OF WAITING, LOADING AND UNLOADING

(i) **Comiston Drive**; (ii) **Comiston Road, both sides**, between its junction with Comiston Drive and its junction with Comiston Terrace; (iii) **Craighill Gardens**; (iv) **Craiglea Drive**; (v) **Craiglea Place**; (vi) **Dalhousie Terrace**; (vii) **St Clair Terrace**; (viii) **St Fillan's Terrace**; (ix) **St Ninian's Terrace**; (x) **St Ronan's Terrace**; (xi) **Comiston Gardens**; (xii) **Comiston Place**; and (xiii) **Ethel Terrace**.
