THE CITY OF EDINBURGH COUNCIL (THE STEILS AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/44

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -


1. This Order may be cited as “The City of Edinburgh Council (The Steils Area) (Temporary Road Restriction and Traffic Regulation) Order 2023” and shall come into operation on the Twentieth day of February Two thousand and twenty-three and shall remain in force up to and including the Thirtieth day of April Two thousand and twenty-three.
2. In this Order the following phrases have the meaning respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for police, fire or ambulance purposes;
“Parking Attendant” has the same meaning as in the 1984 Act;
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
3. Save as provided in Article 4 of this Order, to facilitate CityFibre ducting works (as signed as affected by the works), no person shall:
 - (a) drive or cause or permit to be driven any vehicle on (i) **Wester Steil**, in its entirety; and (ii) **Easter Steil**, between the projected east gable end of No. 19 Easter Steil, westwards to the projected west gable end of No. 10 Easter Steil; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on *both sides* of (i) **Pitcairn Grove**, in its entirety; (ii) **Littlejohn Avenue**, between its junction with Greenbank Drive and its junction with Rattray Loan; (iii) **Rattray Drive**, from its junction with Littlejohn Avenue, northwards for a distance of 45 metres or thereby; (iv) **The Steils**: (1) *southbound one-way section*, between its junction with The Steils and its junction with Greenbank Drive; and (2) from its junction with Mid Steil, southwards and then eastwards to the projected south gable end of No. 40 The Steils; (v) **Wester Steil**, in its entirety; (vi) **Mid Steil**, from its junction with The Steils, generally eastwards to the west gable end of No. 33 Mid Steil; and (vii) **Easter Steil**, from its junction with The Steils, westwards for a distance of 145 metres or thereby.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
6. The alternative route for through vehicular traffic with respect to the *closure* on **Easter Steil** will be by way of The Steils and Easter Steil.

7. The following road has no available diversion, where access will be maintained: (i) **Wester Steil.**
