## THE CITY OF EDINBURGH COUNCIL (CITADEL PLACE & COMMERCIAL STREET) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/28

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Citadel Place & Commercial Street) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect from the Twentieth day of February Two thousand and twenty-three up to and including the Thirty-first day of May Two thousand and twenty-three.
- In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order; "emergency service vehicle" means a vehicle being used for police, fire or ambulance purposes; "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4, to facilitate footway resurfacing and raised entry treatment works (as signed as affected by the works), no person shall:
  - (a) drive or cause or permit to be driven any vehicle on **Citadel Place**, at its junction with Commercial Street; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on (i) Citadel Place, *both sides*, in its entirety; and (ii) Commercial Street, *south side*: (1) from the extended north-western kerbline of Citadel Place, north-westwards for a distance of 40 metres or thereby; and (2) from the extended south-eastern kerbline of Citadel Place, south-eastwards for a distance of 40 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
- 6. The following road has no available diversion: Citadel Place.
