THE CITY OF EDINBURGH COUNCIL (SPYLAW ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/43

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Spylaw Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2023" and shall come into operation on the Twenty-seventh day of February Two thousand and twenty-three and shall remain in force up to and including the Twenty-eighth day of April Two thousand and twenty-three.
- In this Order the following phrases have the meaning respectively assigned to them: "Article" means an Article of this Order; "emergency service vehicle" means a vehicle being used for police, fire or ambulance purposes;
 "Derbing Attendent" has the same meaning as in Section (2A) of the 1084 Act.

"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.

- 3. Save as provided in Article 4 of this Order, to facilitate CityFibre ducting works (as signed as affected by the works), no person shall:
 - (a) drive or cause or permit to be driven any vehicle on the sections of roads described in Schedule 1 hereto; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads described in Schedule 2 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
- 5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

The alternative routes for through vehicular traffic will be by way of: (i) West Castle Road:
(1) Polwarth Terrace, Napier Road, Merchiston Crescent and West Castle Road; and (2) West Castle Road, Polwarth Terrace, Napier Road and Merchiston Crescent; (ii) East Castle Road:
(1) Polwarth Terrace, West Castle Road, Merchiston Crescent and East Castle Road; and (2) East Castle Road, Polwarth Terrace, West Castle Road and Merchiston Crescent; and (iii) East Castle Road, Polwarth Terrace, West Castle Road and Merchiston Crescent; and (iii) Mid Gillsland Road – Spylaw Road, South Ettrick Road and Colinton Road.

SCHEDULE 1 ROAD CLOSURES

(i) **West Castle Road**: (1) from its junction with Polwarth Terrace, southwards to the projected north gable end of No. 8 West Castle Road; and (2) from the projected north gable end of No. 8 West Castle Road, southwards to its junction with Merchiston Crescent; (ii) **East Castle Road**: (1) between its junction with Polwarth Terrace and its junction with Ettrick Grove; and (2) between its junction with Merchiston Crescent; and (iii) **Mid Gillsland Road**, between its junction with Spylaw Road and its junction with Colinton Road.

SCHEDULE 2

PROHIBITION OF WAITING, LOADING AND UNLOADING

(i) **Colinton Road**, *both sides*, between its junction with Mid Gillsland Road and its junction with South Ettrick Road; (ii) **Ettrick Loan**; (iii) **Ettrick Road**; (iv) **Gillsland Road**, *both sides*, between its junction with Gillsland Grove and its junction with Spylaw Road; (v) **Merchiston Crescent**, *both sides*, between its junction with East Castle Road and its junction with Napier Road (*including at its junction with Mardale Crescent*); (vi) **Mid Gillsland Road**; (vii) **Napier Road**, *both sides*, between its junction with Polwarth Terrace and its junction with Spylaw Road; (viii) **Polwarth Terrace**, *both sides*, between its junction with Polwarth Grove and its junction with West Castle Road; (ix) **South Ettrick Road**, *both sides*, between its junction with Spylaw Road and its junction with Colinton Road; (x) **South Gillsland Road**, *both sides*, from its junction with Colinton Road, southwards to the projected south gable end of No. 21 South Gillsland Road; (xi) **Spylaw Road**, *both sides*, from its junction with Napier Road, south-westwards to the projected west gable end of No. 56 Spylaw Road; (xii) **East Castle Road**; (xiii) **Ettrick Grove**; and (xiv) **West Castle Road**.
