THE CITY OF EDINBURGH COUNCIL (CCWEL HAYMARKET TERRACE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/58

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (CCWEL Haymarket Terrace Area) (Temporary Road Restriction and Traffic Regulation) Order 2023" and shall come into operation on the Twentieth day of March Two thousand and twenty-three and shall remain in force up to and including the Twentieth day of September Two thousand and twenty-three.
- 2. In this Order the following phrases have the meaning respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for police, fire or ambulance purposes;
 - "motor vehicle" has the same meaning as in Section 136 of the 1984 Act;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4 of this Order, to facilitate public realm works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on **Haymarket Terrace**, from a point 20 metres or thereby east of the extended eastern kerbline of Rosebery Crescent, westwards to the extended eastern kerbline of Magdala Crescent, otherwise than in a *westbound* direction:
 - (b) drive or cause or permit to be driven any motor vehicle on **Rosebery Crescent**, at its junction with Haymarket Terrace;
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on: (i) **Haymarket Terrace**, *north side*: (1) from a point 20 metres or thereby east of the extended eastern kerbline of Rosebery Crescent, westwards to the extended eastern kerbline of Magdala Crescent; and (2) from the extended north-western kerbline of Dalry Road (A70), westwards to its junction with West Coates; and (ii) **West Coates**, *north side*, from its junction with Haymarket Terrace, westwards to the extended western kerbline of Devon Place; and
 - (d) drive or cause or permit to be driven any vehicle on the road described in column 1 of Schedule 1 so as to make the prohibited turn specified in column 2 of Schedule 1, into the road specified in column 3 of Schedule 1.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
- 5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3(c) of this Order.

- 6. The alternative route for through vehicular traffic with respect to the *one-way restriction* on **Haymarket Terrace** will be by way of Magdala Crescent, Eglinton Crescent, Palmerston Place, Lansdowne Crescent, Grosvenor Street and Clifton Terrace.
- 7. The alternative route for through vehicular traffic with respect to the *prohibition of motor vehicles* on **Rosebery Crescent** will be by way of Grosvenor Crescent, Lansdowne Crescent, Grosvenor Street and Clifton Terrace.
- 8. The alternative routes for through vehicular traffic with respect to the *prohibited turns* will be by way of: (i) **Grosvenor Gardens** Grosvenor Crescent, Lansdowne Crescent, Grosvenor Street and Clifton Terrace; (ii) **Haymarket Yards** Haymarket Terrace (A8), Magdala Crescent, Eglinton Crescent, Palmerston Place, Lansdowne Crescent, Grosvenor Street and Clifton Terrace; (iii) **Rosebery Crescent Lane** Grosvenor Crescent, Lansdowne Crescent, Grosvenor Street and Clifton Terrace; (iv) **Coates Gardens** Haymarket Terrace (A8), Magdala Crescent, Eglinton Crescent, Palmerston Place, Lansdowne Crescent, Grosvenor Street and Clifton Terrace; and (v) **Eglinton Crescent** Magdala Crescent, Douglas Crescent, Palmerston Place, Lansdowne Crescent, Grosvenor Street and Clifton Terrace.
