THE CITY OF EDINBURGH COUNCIL (BRUNTSFIELD PLACE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/63

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Bruntsfield Place Area) (Temporary Road Restriction and Traffic Regulation) Order 2023" and shall come into operation on the Third day of April Two thousand and twenty-three and shall remain in force up to and including the Eighteenth day of June Two thousand and twenty-three.
- 2. In this Order the following phrases have the meaning respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for police, fire or ambulance purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4 of this Order, to facilitate CityFibre ducting works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on (i) **Admiral Terrace**, at its junction with Westhall Gardens; (ii) **Hartington Gardens**, at its junction with Viewforth; and (iii) **Bruntsfield Avenue**, at its junction with Bruntsfield Place; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on (i) **Bruntsfield Place**, *both sides*, from a point 30 metres or thereby south-west of the extended south-western kerbline of Viewforth, north-eastwards for a distance of 80 metres or thereby; (ii) **Admiral Terrace**; (iii) **Viewforth**, *both sides*, between its junction with Hartington Place and its junction with Bruntsfield Place; (iv) **Westhall Gardens**; (v) **Hartington Gardens**; (vi) **Montpelier**; and (vii) **Bruntsfield Avenue**, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
- 5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
- 6. The following *closures* have no available diversion, where access will be maintained: (i) **Admiral Terrace**; (ii) **Hartington Gardens**; and (iii) **Bruntsfield Avenue**.
