THE CITY OF EDINBURGH COUNCIL (HERMITAGE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/66

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Hermitage Area) (Temporary Road Restriction and Traffic Regulation) Order 2023" and shall come into operation on the Eighth day of April Two thousand and twenty-three and shall remain in force up to and including the Thirtieth day of June Two thousand and twenty-three.
- 2. In this Order the following phrases have the meaning respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for police, fire or ambulance purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4 of this Order, to facilitate CityFibre ducting works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on (i) **Comiston Terrace**, between its junction with Comiston Road and its junction with Braid Road; (ii) **Comiston Place**, between its junction with Comiston Road and its junction with Braid Road; and (iii) **Cluny Drive**, between its junction with Braid Road and its junction with Hermitage Gardens; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on *both sides* of (i) **Hermitage Drive**, from the projected west gable end of No. 4 Hermitage Drive, eastwards to its junction with Midmar Gardens; (ii) **Corrennie Gardens**, in its entirety; (iii) **Hermitage Gardens**, between its junction with Hermitage Drive and its junction with Comiston Drive; (iv) **Comiston Road**, between its junction with Braid Crescent and its junction with Comiston Terrace; (v) **Comiston Terrace**, in its entirety; (vi) **Cluny Drive**, between its junction with Braid Road and its junction with Hermitage Gardens; and (vii) **Corrennie Drive**, between its junction with Hermitage Gardens and its junction with Corrennie Gardens.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
- 5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3(b) of this Order.

6. The alternative routes for through vehicular traffic with respect to the *closures* will be by way of: (i) Comiston Terrace – Comiston Road, Comiston Place and Braid Road; (ii) Comiston Place – Comiston Road, Comiston Terrace and Braid Road; and (iii) Cluny Drive – Braid Road, Braid Crescent and Hermitage Gardens.
