
THE CITY OF EDINBURGH COUNCIL (SOUTH QUEENSFERRY CRUISELINER VISITS)  
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 –  
TEMP/23/106

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (South Queensferry Cruiseline Visits) (Temporary Road Restriction and Traffic Regulation) Order 2023”. The Order shall have effect on the dates and during the hours specified in the Schedules to this Order.
2. In this Order the following phrases have the meanings respectively assigned to them:
  - “Article” means an Article of this Order;
  - “coach” means a public service vehicle provided that the said vehicle or vehicles are not being operated as a Local Service (as the same is defined in the Transport Act 1985);
  - “emergency service vehicle” means a vehicle being used for ambulance, fire and police purposes;
  - “motor vehicle” has the same meaning as in Section 136 of the 1984 Act;
  - “Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
  - “public service vehicle” has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981, and, for the purposes of this Order, applies where the said vehicle or vehicles are being operated as a Local Service, as defined in the said Act;
  - “local buses” means a public service vehicle used for the provision of a local service not being an excursion or tour, and for the purposes of this Order, includes a cruise liner shuttle bus;
  - “Schedule” means a Schedule to this Order; and
  - “taxi” shall have the meaning given to that word by Section 23 of the Civic Government (Scotland) Act 1982; and
  - “the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restriction on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
3. Save as provided in Article 4 of this Order, to facilitate cruise liner visits (as signed as affected by the cruiseline visits), no person shall:-
  - (a) drive or cause or permit any motor vehicle to be driven on the section of road specified in Schedule 1 hereto; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the roads specified in Schedule 2 hereto.
4. Nothing in:
  - (i) Article 3 of this Order shall apply to emergency service vehicles;
  - (ii) Article 3(a) of this Order shall apply to cruise coach services and Lothian Bus Service No. 43;
  - (iii) Article 3(b) of this Order shall apply to local service bus No. X99 or RNLI & Coastguard vehicles in relation to the sections of **Newhalls Road** described in Schedule 2 hereto;
  - (iv) Article 3(b) of this Order shall apply to private coaches and authorised vehicles in relation to the section of **Hawes Brae** described in Schedule 2 hereto; and

- (v) Article 3(b) of this Order shall apply to taxis in relation to the four easternmost disabled bays in Hawes Car Park.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Schedule 2 to this Order.
6. The alternative route for through vehicular traffic with respect to the ***prohibition on motor vehicles*** on **Bankhead Road** will be by way of Bankhead Road, B924 and Main Street.
