THE CITY OF EDINBURGH COUNCIL (VARIOUS ROADS, EDINBURGH) (RESTRICTIONS AND PROHIBITIONS ON WAITING, LOADING AND UNLOADING) AND (BUS PRIORITY MEASURES) (NO. 1) EXPERIMENTAL TRAFFIC ORDER 2023 - ETRO/23/13

The City of Edinburgh Council in exercise of their powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 as amended (which Act as so amended is hereinafter referred to as "the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:

# Citation, commencement and expiry

- 1. This Order may be cited as "The City of Edinburgh Council (Various Roads, Edinburgh) (Restrictions and Prohibitions on Waiting, Loading and Unloading) and (Bus Priority Measures) (No. 1) Experimental Traffic Order 2023", shall come into force on the Twelfth day of June Two thousand and twenty-three, and shall expire on the Eleventh day of December Two thousand and twenty-four.
- 2. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.

## Restrictions of waiting and loading or unloading

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Edinburgh Corporation (Various Streets) (Prohibition of Waiting) Order 1967 shall have effect subject to the variations, insertions, substitutions and additions thereto specified in Schedule 1 to this Order.

### Bus lanes

4. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of Edinburgh Council (A701, Newington Road to Straiton Road, Edinburgh) (Bus Priority Measures) Traffic Regulation Order 2003 shall have effect subject to the variations, insertions, substitutions and additions thereto specified in Schedule 2 to this Order.
