THE CITY OF EDINBURGH COUNCIL (THE PROCLAIMERS @ LEITH LINKS) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/132

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 62 of the Roads (Scotland) Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (The Proclaimers @ Leith Links) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect during the hours and on the dates specified in the Schedule to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire or police purposes;
 - "event vehicle" means any vehicle authorised by City of Edinburgh Council as being connected with the event;
 - "Parking Attendant" has the same meaning as in Section 63A of the Road Traffic Regulation Act 1984;
 - "Schedule" means a Schedule to this Order;
 - "vehicle" has the same meaning as in Section 151 of the 1984 Act; and
 - "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4, to facilitate the holding of The Proclaimers @ Leith Links event (as signed as affected by the event), no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads specified in Schedule 1 hereto.
- 4. Nothing in Article 3 shall apply to:
 - (i) event vehicles on the sections of **Links Gardens** described in Schedule 1; and
 - (ii) emergency service vehicles.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions described in Article 3 of this Order.

SCHEDULE 1 PROHIBITION OF WAITING, LOADING & UNLOADING

(A) from 08:00 hours on 09/06/2023 to 18:00 hours on 23/06/2023 on:

Links Gardens: (1) *south-west side*, from its junction with Links Place to a point opposite its junction with Links Gardens Lane (*except event vehicles*); and (2) *both sides*, from a point 70 metres or thereby north of the extended northern kerbline of East Hermitage Place, northwards for a distance of 80 metres or thereby (*except event vehicles*); and

(B) from 14:00 hours on 17/06/2023 to 23:00 hours on 18/06/2023 on:

(i) **Links Gardens**, both sides, from its junction with East Hermitage Place, northwards for a distance of 70 metres or thereby; (ii) Vanburgh Place, north side, from a point 30 metres or thereby east of the extended eastern kerbline of Lochend Road, eastwards for a distance of 40 metres or thereby (except City Car Club bay); (iii) Hermitage Place: (a) north side, from its junction with Vanburgh Place, eastwards for a distance of 35 metres or thereby; and (b) south side, from its junction with East Hermitage Place, westwards for a distance of 45 metres or thereby; (iv) East Hermitage Place: (a) north side: (1) from its junction with Hermitage Place, eastwards for a distance of 20 metres or thereby; and (2) from its junction with Links Gardens, westwards for a distance of 35 metres or thereby; and (b) south side: (1) from its junction with Somerset Place, eastwards for a distance of 5 metres or thereby; (2) from its junction with Fingzies Place, eastwards and westwards for a distance of 5 metres or thereby respectively; (3) from its junction with Parkvale Place, eastwards and westwards for a distance of 5 metres or thereby respectively; and (4) from its junction with Summerfield Place, westwards for a distance of 35 metres or thereby; (v) **Somerset Place**, both sides, from its junction with East Hermitage Place, southwards for a distance of 6 metres or thereby; (vi) Fingzies Place: (a) west side, from its junction with East Hermitage Place, southwards for a distance of 6 metres or thereby; and (b) east side, between its junction with East Hermitage Place and its junction with Industrial Road; (vii) Parkvale Place: (a) west side, from its junction with East Hermitage Place, southwards for a distance of 6 metres or thereby; and (b) east side, between its junction with East Hermitage Place and its junction with Industrial Road; (viii) Summerfield Place, west side, from its junction with East Hermitage Place, southwards for a distance of 6 metres or thereby; (ix) **Restalrig** Road, both sides, from its junction with East Hermitage Place, southwards for a distance of 50 metres or thereby; (x) Gladstone Place: (a) north side, from its junction with Links Gardens, eastwards for a distance of 75 metres or thereby; and (b) south side, from its junction with Summerfield Gardens, westwards for a distance of 15 metres or thereby; (xi) Claremont Park: (a) north side, from a point 30 metres or thereby east of its junction with Claremont Road, westwards for a distance of 40 metres or thereby; and (b) south side: (1) from its junction with Summerfield Gardens, eastwards for a distance of 15 metres or thereby; (2) from its junction with Claremont Road, westwards for a distance of 15 metres or thereby; and (3) from its junction with Claremont Road, eastwards for a distance of 48 metres or thereby; (xii) Summerfield Gardens, both sides, from its junction with Gladstone Place, southwards for a distance of 7 metres or thereby; and (xiii) Claremont Road, both sides, from its junction with Claremont Park, southwards for a distance of 7 metres or thereby.
