THE CITY OF EDINBURGH COUNCIL (GUMBALL 3000 RALLY) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/135

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other enabling powers being satisfied that traffic on the lengths of roads specified in the Schedules hereto should be prohibited or restricted to facilitate the holding of the Gumball 3000 Rally event and to enable members of the public to watch this event and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, with the consent of the Scottish Ministers under section 16B(6)(b) of the said Act, hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Gumball 3000 Rally) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect during the hours and on the dates specified in the Schedules to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;

"emergency service vehicle" means a vehicle being used for ambulance, fire or police purposes;

"local buses" means a public service vehicle used for the provision of a local service not being an excursion or tour;

"motor vehicle" has the same meaning as in Section 136 of the 1984 Act;

"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "public service vehicle" has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981, and, for the purposes of this Order, applies where the said vehicle or vehicles are being operated as a Local Service, as defined in the said Act; "Schedule" means a Schedule to this Order;

"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.

- 3. Save as provided in Article 4, to facilitate the holding of Gumball 3000 Rally (as signed as affected by the event), no person shall:-
 - (a) drive or cause or permit to be driven any motor vehicle on the sections of roads specified in Schedule 1 hereto; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads specified in Schedule 2 hereto.
- 4. Nothing in:
 - (i) Article 3(a) shall apply to *local buses* on the section of **Frederick Street** described in Schedule 1; and
 - (ii) Article 3 shall apply to emergency service vehicles.
- 5. The 2018 Order shall be suspended in so far as it is affected by the restrictions specified in Schedule 2 of this Order.

6. The alternative route for through vehicular traffic with respect to the *prohibition of motor vehicles* will be by way of North Charlotte Street, Queen Street and Hanover Street.

SCHEDULE 1 PROHIBITION OF MOTOR VEHICLES

(A) from 23:59 hours on 09/06/2023 to 16:00 hours on 11/06/2023 on:

George Street: (1) between its junction with Charlotte Square and its junction with Castle Street; and (2) between its junction with Castle Street and its junction with Frederick Street.

(B) from 23:59 hours on 10/06/2023 to 16:00 hours on 11/06/2023 on:

George Street, between its junction with Frederick Street and its junction with Hanover Street.

(C) from 09:00 hours to 16:00 hours on 11/06/2023 on:

(i) **George Street**, across the junctions of Castle Street and North Castle Street; and (ii) **Frederick Street**, between a point 25 metres or thereby north of its junction with George Street and a point 20 metres or thereby south of its junction with George Street (*except local buses*).

SCHEDULE 2 PROHIBITION OF WAITING, LOADING & UNLOADING

(A) from 23:59 hours on 09/06/2023 to 16:00 hours on 11/06/2023 on:

George Street, *both sides*, between its junction with Charlotte Square and its junction with Frederick Street (*including central reserve parking bays*).

(B) from 23:59 hours on 10/06/2023 to 16:00 hours on 11/06/2023 on:

(i) **George Street**, *both sides*, between its junction with Frederick Street and its junction with Hanover Street (*including central reserve parking bays*); (ii) **Hanover Street**, *both sides*, between its junction with George Street and its junction with Princes Street; and (iii) **The Mound**, *both sides*, in its entirety.
