THE CITY OF EDINBURGH COUNCIL (UCI CYCLING WORLD CHAMPIONSHIPS)
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 –
TEMP/23/191

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other enabling powers being satisfied that traffic on the lengths of roads specified in Article 3 should be prohibited or restricted to facilitate the holding of the UCI Cycling World Championships event, and to enable members of the public to watch this event and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, with the consent of the Scottish Ministers under section 16B(6)(b) of the said Act, hereby make the following Order: -


1. This Order may be cited as "The City of Edinburgh Council (UCI Cycling World Championships) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect during the hours and on the dates specified in the Schedules of this Order.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“motor vehicle” has the same meaning as in Section 136 of the 1984 Act;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“Schedule” means a Schedule to this Order;
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
3. Save as provided in Article 4, to facilitate the holding of the UCI Cycling World Championships (as signed as affected by the event), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on the sections of roads specified in Schedule 1 hereto, where closures will apply to the entire road unless otherwise stated;
 - (b) drive or cause or permit to be driven any motor vehicle on the sections of roads specified in column 1 of Schedule 2, otherwise than in the direction specified in column 2 of Schedule 2 hereto; and
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads specified in Schedule 3 hereto, where prohibitions will apply to both sides of the entire road unless otherwise stated.
4. Nothing in Article 3 of this Order shall apply to emergency service vehicles.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(c) of this Order.

6. The restrictions imposed by Article 3 in this Order shall repeal any existing provision, restriction or requirement imposed by any regulations made or having effect as if made under Section 14 or 16 of the Road Traffic Regulation Act 1984, as amended, as aforesaid or by or under any other enactment, whilst the provisions of this Order are in operation in accordance with Article 3 of this Order.
7. The alternative route for through vehicular traffic will be by way of Glasgow Road (A8), Corstorphine Road, West Coates, Haymarket Terrace, West Maitland Street, Palmerston Place, Douglas Gardens, Belford Road, Queensferry Terrace, Lothian Road, Charlotte Square, Queen Street, York Place, Leith Street, London Road, North Bridge and South Bridge.

(i) **Queen's Drive**; (ii) **Horse Wynd**; and (iii) **Duke's Walk**;

(B) from 23:59 hours on 05/08/2023 to 13:45 hours on 06/08/2023 on:

(i) **Canongate**; and (ii) **New Street**, between its junction with East Market Street and its junction with Canongate;

(C) from 23:59 hours on 05/08/2023 to 11:15 hours on 06/08/2023 on:

(i) **High Street**, between its junction with South Bridge and its junction with St Giles Street; and (ii) **Lawnmarket**, between its junction with St Giles' Street and its junction with Bank Street;

(D) from 23:59 hours on 05/08/2023 to 12:00 hours on 06/08/2023 on:

High Street, between its junction with St Mary's Street and its junction with South Bridge;

(E) from 08:00 hours to 09:45 hours on 06/08/2023 on:

(i) **Abbeyhill**, between its junction with Canongate and its junction with Abbeyhill Crescent; and (ii) **Calton Road**, between its junction with Abbeyhill and its junction with Abbeyhill Crescent;

(F) from 09:00 hours to 09:45 hours on 06/08/2023 on:

(i) **George IV Bridge**, between its junction with Lawnmarket and its junction with Victoria Street; (ii) **Lawnmarket**, between its junction with Bank Street and its junction with Castlehill; (iii) **Bank Street**; (iv) **North Bank Street**; (v) **The Mound**; (vi) **Hanover Street**; (vii) **Queen Street Gardens East**; (viii) **Heriot Row**, between its junction with Dundas Street and its junction with Howe Street; (ix) **Howe Street**, between its junction with Heriot Row and its junction with South-East Circus Place; (x) **South-East Circus Place**; (xi) **Circus Place**; and (xii) **North-West Circus Place**;

(G) from 09:10 hours to 09:45 hours on 06/08/2023 on:

(i) **Kerr Street**; (ii) **Deanhaugh Street**; (iii) **Raeburn Place**; (iv) **Comely Bank Road**; and (v) **Craigleith Road**;

(H) from 09:15 hours to 09:50 hours on 06/08/2023 on:

(i) **Queensferry Road**, between its junction with Craigleith Road and its junction with Hillhouse Road; and (ii) **Hillhouse Road**;

(I) from 09:20 hours to 09:55 hours on 06/08/2023 on:

Queensferry Road, between its junction with Hillhouse Road and its junction with Maybury Road; and

(J) from 09:40 hours to 10:00 hours on 06/08/2023 on:

Queensferry Road, from its junction with Whitehouse Road, north-westwards to a point 40 metres or thereby north-west of its junction with Cramond Brig Farm House Road.

(A) from 18:30 hours on 05/08/2023 to 12:00 hours on 06/08/2023 on:

(i) **Queen's Drive**; (ii) **Horse Wynd**; (iii) **Duke's Walk**; (iv) **Canongate**; (v) **High Street**; and (vi) **Lawnmarket, both sides**, between its junction with St Giles' Street and its junction with Bank Street; and

(B) from 05:00 hours to 10:30 hours on 06/08/2023 on:

(i) **Abbeyhill, both sides**, between its junction with Canongate and its junction with Abbeyhill Crescent; (ii) **Calton Road, both sides**, between its junction with Abbeyhill and its junction with Lochend Close (*except recessed bays*); (iii) **New Street, both sides**, between its junction with Canongate and its junction with East Market Street; (iv) **Jeffrey Street, both sides**, from its junction with Canongate, northwards for a distance of 30 metres or thereby; (v) **St Mary's Street, both sides**, from its junction with Canongate, southwards for a distance of 30 metres or thereby; (vi) **Blackfriars Street, both sides**, from its junction with Canongate, southwards for a distance of 30 metres or

thereby; (vii) **Niddry Street, both sides**, from its junction with Canongate, southwards for a distance of 30 metres or thereby; (viii) **North Bridge, both sides**, from its junction with High Street, northwards for a distance 30 metres or thereby; (ix) **South Bridge, both sides**, between its junction with Blair Street and its junction with High Street; (x) **Cockburn Street, both sides**, from its junction with Canongate, northwards for a distance of 30 metres or thereby; (xi) **Lawnmarket, both sides**, between its junction with George IV Bridge and its junction with Castlehill; (xii) **George IV Bridge, both sides**, between its junction with Lawnmarket and its junction with Victoria Street; (xiii) **Bank Street**; (xiv) **North Bank Street**; (xv) **The Mound**; (xvi) **Hanover Street**; (xvii) **Queen Street Gardens East**; (xviii) **Heriot Row, both sides**, between its junction with Dundas Street and its junction with Howe Street; (xix) **Howe Street, both sides**, between its junction with Heriot Row and its junction with South-East Circus Place; (xx) **South-East Circus Place**; (xxi) **Circus Place**; (xxii) **North-West Circus Place**; (xxiii) **Kerr Street**; (xxiv) **Deanhaugh Street**; (xxv) **Raeburn Place**; and (xxvi) **Comely Bank Road**.
