THE CITY OF EDINBURGH COUNCIL (JOHNSBURN ROAD AREA, BALERNO)  
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 –  
TEMP/23/197

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Johnsburn Road Area, Balerno) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect from the Second day of October Two thousand and twenty-three up to and including the Eleventh day of December Two thousand and twenty-three.
2. In this Order the following phrases have the meanings respectively assigned to them:  
“Article” means an Article of this Order;  
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;  
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;  
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate carriageway planing and resurfacing works (as signed as affected by the works), no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on **both sides** of (i) **Johnsburn Road**, from its junction with Main Street roundabout, south-westwards to the projected south-west property boundary of No. 17 Johnsburn Road; (ii) **Main Street**: (1) roundabout in its entirety; and (2) from its junction with the roundabout, south-eastwards for a distance of 50 metres or thereby; (iii) **Larchfield**, from its junction with Main Street roundabout, north-westwards for a distance of 30 metres or thereby; (iv) **Bridge Road**, from its junction with Main Street roundabout, north-eastwards for a distance of 25 metres or thereby; (v) **Burnside Park**, from its junction with Johnsburn Road, north-westwards for a distance of 20 metres or thereby; and (vi) **Lovedale Road**, from its junction with Johnsburn Road, south-eastwards for a distance of 15 metres or thereby.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3 of this Order.
