THE CITY OF EDINBURGH COUNCIL (CHARLOTTE SQUARE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/222

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Charlotte Square Area) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect from the Second day of October Two thousand and twenty-three up to and including the Twenty-fourth day of November Two thousand and twenty-three.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate carriageway resurfacing and drainage improvement works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle: (1) at any time on: George Street (both carriageways), from its junction with Charlotte Square (east leg), eastwards for a distance of 30 metres or thereby; (2) DAILY from 7am to 7pm on: (i) Charlotte Square (north side), in its entirety; (ii) Charlotte Square (west side), in its entirety; and (iii) Charlotte Square (south side), in its entirety; and (3) DAILY from 7pm to 6am on: (i) Charlotte Square (east side), in its entirety; (ii) North Charlotte Street, in its entirety; and (iii) South Charlotte Street, in its entirety;
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i)
 Charlotte Square, in its entirety; (ii) North Charlotte Street, in its entirety; (iii)
 South Charlotte Street, in its entirety; and (iv) George Street (both carriageways), from its junction with Charlotte Square (east leg), eastwards for a distance of 30 metres or thereby; and
 - (c) drive or cause or permit to be driven any vehicle on the road described in column 1 of Schedule 1 so as to make the prohibited turn specified in column 2 of Schedule 1, into the road specified in column 3 of Schedule 1 hereto.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
- 6. 'The Corporation of Edinburgh (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, and Parking Places) Order 1973' will be suspended on **Charlotte Square**, in so far as it is affected by the restrictions specified in Article 3 of this Order.

- 7. The alternative routes for through vehicular traffic with respect to the *closures* will be by way of: (i) *northbound*: Lothian Road, West Approach Road, Morrison Link, Morrison Street, West Maitland Street, Palmerston Place, Chester Street, Drumsheugh Gardens, Queensferry Street, Randolph Crescent, Great Stuart Street, Ainslie Place, St Colme Street and Albyn Place; and (ii) *southbound*: Albyn Place, St Colme Street, Ainslie Place, Great Stuart Street, Randolph Crescent, Melville Street, Manor Place, Atholl Place, Torphichen Street, Deward Place, Morrison Street and Lothian Road.
- 8. The alternative routes for through vehicular traffic with respect to the *prohibition of turning* will be by way of: (i) **Charlotte Square** (*north leg*) Charlotte Square; and (ii) **Charlotte Square** (*east leg*) North Charlotte Street, Albyn Place, Queen Street, North Castle Street and George Street.
