THE CITY OF EDINBURGH COUNCIL (CORSTORPHINE CONNECTIONS) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/224

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Corstorphine Connections) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect from the Second day of October Two thousand and twenty-three up to and including the Thirtieth day of November Two thousand and twenty-three.
2. In this Order the following phrases have the meanings respectively assigned to them:
 - “Article” means an Article of this Order;
 - “emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
 - “Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
 - “the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
 - “vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate active travel streetscape improvement works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on the sections of roads described in Schedule 1 hereto; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on **both sides** of the sections of roads described in Schedule 2 hereto.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
6. ‘The City of Edinburgh Council (Various Streets, Corstorphine) (Experimental Traffic Management Measures) (No. 1) Experimental Order 2023’ shall be suspended in relation to the **bus lane** on **Manse Road**, to facilitate the execution of the works specified in Article 3 of this Order.

7. The alternative routes for through vehicular traffic will be by way of: (i) **Roull Road** – Saughton Road North and Castle Avenue; (ii) **Broomfield Crescent** – Saughton Road North and Broomfield Crescent (*southernmost junction*); (iii) **Dovecot Road** – Ladywell Avenue, Castle Avenue and Saughton Road North; (iv) **Featherhall Terrace**: (1) *westbound* – Manse Road, St John’s Road and Featherhall Avenue; and (2) *eastbound* – Featherhall Avenue, Corstorphine High Street and Manse Road; (v) **Featherhall Road** – Manse Street, Manse Road, St John’s Road and Featherhall Avenue; (vi) **Manse Street**: (1) *westbound* – Manse Road, Featherhall Terrace and Featherhall Road; and (2) *eastbound* – Featherhall Avenue, Featherhall Terrace and Featherhall Road; (vii) **Tyler’s Acre Road**: (1) *northbound* – Lampacre Road and Tyler’s Acre Avenue; and (2) *southbound* – Meadowhouse Road and Saughton Road North; and (viii) **Tyler’s Acre Gardens**: (1) *northbound* – Lampacre Road, Tyler’s Acre Avenue and Tyler’s Acre Road; and (2) *southbound* – Meadowhouse Road, Saughton Road North and Tyler’s Acre Road.

SCHEDULE 1 ROAD CLOSURES

(i) **Roull Road**, from a point 71 metres or thereby south-west of the extended western kerbline of Saughton Road North, north-eastwards to a point 9 metres or thereby west of the extended eastern kerbline of Saughton Road North; (ii) **Broomfield Crescent** (*northernmost junction*), from a point 55 metres or thereby south-west of the extended south-western kerbline of Saughton Road North, north-eastwards to a point 9 metres or thereby south-west of the extended north-eastern kerbline of Saughton Road North; (iii) **Dovecot Road**, from a point 7 metres or thereby north-east of the extended western kerbline of Ladywell Avenue, north-eastwards to a point 315 metres or thereby south-west of the extended western kerbline of Saughton Road North; (iv) **Featherhall Terrace**, from a point 9 metres or thereby east of the extended western kerbline of Featherhall Avenue, eastwards to a point 31 metres or thereby west of the extended western kerbline of Featherhall Place; (v) **Featherhall Road**, from a point 6 metres or thereby south of the extended northern kerbline of Featherhall Terrace, southwards to a point 16 metres or thereby south of the extended southern kerbline of Featherhall Terrace; (vi) **Manse Street**, from a point 3 metres or thereby west of the extended eastern kerbline of Manse Road, eastwards to a point 29 metres or thereby west of the extended western kerbline of Featherhall Road; (vii) **Tyler’s Acre Road**, from a point 238 metres or thereby east of the extended eastern kerbline of Saughton Road North, eastwards to a point 6 metres or thereby west of the extended eastern kerbline of Lampacre Road; and (viii) **Tyler’s Acre Gardens**, from a point 6 metres or thereby west of the extended eastern kerbline of Lampacre Road, westwards to a point 30 metres or thereby west of the extended eastern kerbline of Lampacre Road.

SCHEDULE 2
PROHIBITION OF WAITING, LOADING AND UNLOADING

(i) **Roull Road**, from a point 71 metres or thereby south-west of the extended western kerbline of Saughton Road North, north-eastwards to a point 9 metres or thereby west of the extended eastern kerbline of Saughton Road North; (ii) **Broomfield Crescent** (*northernmost junction*), from a point 55 metres or thereby south-west of the extended south-western kerbline of Saughton Road North, north-eastwards to a point 9 metres or thereby south-west of the extended north-eastern kerbline of Saughton Road North; (iii) **Saughton Road North**: (1) from a point 48 metres or thereby north of the extended northern kerbline of Roull Road, southwards to a point 19 metres or thereby south of the extended southern kerbline of Broomfield Crescent; and (2) from a point 42 metres or thereby south of the extended southern kerbline of Kirk Loan, generally northwards for a distance of 75 metres or thereby; (iv) **Kirk Loan**, from a point 57 metres or thereby east of the extended western kerbline of Saughton Road North, westwards to a point 9 metres or thereby east of the extended western kerbline of Saughton Road North; (v) **Corstorphine High Street**, from a point 6 metres or thereby east of the extended western kerbline of Manse Road, eastwards for a distance of 98 metres or thereby; (vi) **Dovecot Road**, from a point 7 metres or thereby east of the extended western kerbline of Ladywell Avenue, north-eastwards to a point 66 metres or thereby east of the extended eastern kerbline of Ladywell Avenue; (vii) **Ladywell Avenue**, from a point 27 metres or thereby north of the extended north-western kerbline of Dovecot Road, southwards to a point 28 metres or thereby south of the extended south-eastern kerbline of Dovecot Road; (viii) **Featherhall Terrace**, from a point 9 metres or thereby east of the extended western kerbline of Featherhall Avenue, eastwards to a point 20 metres or thereby west of the extended western kerbline of Featherhall Place; (ix) **Featherhall Road**, from a point 6 metres or thereby south of the extended northern kerbline of Featherhall Terrace, southwards to a point 36 metres or thereby south of the extended southern kerbline of Featherhall Terrace; (x) **Featherhall Avenue**, from a point 21 metres or thereby north of the extended northern kerbline of Featherhall Terrace, southwards to a point 22 metres or thereby south of the extended southern kerbline of Featherhall Terrace; (xi) **Manse Road**, from a point 20 metres or thereby north of the extended northern kerbline of Manse Street, southwards to a point 28 metres or thereby south of the extended southern kerbline of Manse Street; (xii) **Manse Street**, from a point 100 metres or thereby east of the extended western kerbline of Featherhall Road, eastwards to a point 26 metres or thereby west of the extended eastern kerbline of Manse Road; (xiii) **Tyler's Acre Road**, from a point 218 metres or thereby east of the extended eastern kerbline of Saughton Road North, eastwards to a point 6 metres or thereby west of the extended eastern kerbline of Lampacre Road; (xiv) **Tyler's Acre Gardens**, from a point 6 metres or thereby west of the extended eastern kerbline of Lampacre Road, westwards to a point 62 metres or thereby west of the extended eastern kerbline of Lampacre Road; and (xv) **Lampacre Road**: (1) from a point 31 metres or thereby north of the extended northern kerbline of Tyler's Acre Road, southwards to a point 43 metres or thereby south of the extended southern kerbline of Tyler's Acre Road; and (2) from a point 58 metres or thereby north of the extended northern kerbline of Tyler's Acre Gardens, southwards to a point 47 metres or thereby south of the extended southern kerbline of Tyler's Acre Gardens.
