ROADS (SCOTLAND) ACT 1984

THE CITY OF EDINBURGH COUNCIL (TELFORD ROAD AND HOUSE O'HILL ROAD AREA, EDINBURGH) (REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER 202- **- RSO/23/08**

The City of Edinburgh Council, in exercise of the powers conferred on them by section 1(1) and 152 (2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

1. This Order may be cited as "The City of Edinburgh Council (Telford Road and House O'Hill Road Area, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 202-" and shall come into operation on the --- day of --- Two thousand and twenty-__.
2. The roads in the City of Edinburgh local government area specified in Schedule 1 to this Order, at present carriageway, shall become footway, the right of passage being exercisable by foot only.

SCHEDULE 1

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY

House O'Hill Road, Drylaw Crescent and Telford Road

- a) All that part of the carriageway on the north-east side of House O'Hill Road at Drylaw Crescent from a point 14 metres or thereby south of the extended south-west building line of No.2 House O'Hill Road southwards then eastwards to a point 10 metres or thereby south-west of the extended south-west building line of No.2 House O'Hill Road and which has a width that varies from 0 metres or thereby to 0.8 metres or thereby.
(marked A1 on the attached plans)
- b) All that part of the carriageway on the south-east side of Drylaw Crescent at House O'Hill Road from a point 2.2 metres or thereby south-west of the extended north-east building line of no.55 Drylaw Crescent southwards then eastwards to a point 8.5 metres or thereby west of the property boundary of No.19 and No.21 Telford Road and which has a width that varies from 0 metres or thereby to 5.9 metres or thereby.
(marked A2 on the attached plans)
- c) All that part of the carriageway on the north-west side of House O'Hill Road at Telford Road from a point 13 metres or thereby south-east of the extended south-east property boundary of Blackhall Mosque southwards then westwards to a point 20 metres or thereby east of the property boundary of No.15 Telford Road and which has a width that varies from 0 metres or thereby to 5.5 metres or thereby.
(marked A3 on the attached plans)

All as the lengths of roads are shown in sawtooth hatching on the plan annexed and executed as relative to the Order.
