<u>SCHEDULE 1</u> ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY

House O'Hill Rd, Drylaw Cres and Telford Rd a) All that part of the carriageway on the north-east side of House O'Hill Rd at Drylaw Cres from a point 14m or thereby south of the extended south-west building line of No.2 House O'Hill Rd southwards then eastwards to a point 10m or thereby south-west of the extended south-west building line of No.2 House O'Hill Rd and which has a width that varies from 0m or thereby to 0.8m or thereby. b) All that part of the carriageway on the south-east side of Drylaw Cres at House O'Hill Rd from a point 2.2m or thereby south-west of the extended north-east building line of no.55 Drylaw Cres southwards then eastwards to a point 8.5m or thereby west of the property boundary of No.19 and No.21 Telford Rd and which has a width that varies from 0m or thereby to 5.9m or thereby. c) All that part of the carriageway on the north-west side of House O'Hill Rd at Telford Rd from a point 13m or thereby south-east of the extended south-east property boundary of Blackhall Mosque southwards then westwards to a point 20m or thereby east of the property boundary of No.15 Telford Rd and which has a width that varies from 0m or thereby to 5.5m or thereby.
