

The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) (Variation No _) Order 202_- TRO/21/18

The Council proposes to make an Order under the Road Traffic Regulation Act 1984 as amended to introduce the following restrictions: **1.** Replace a shared use parking bay with a daytime waiting restriction (Mon-Fri 8.30am-5.30pm) on Lauder Rd, Duff St and Dean St; **2.** Replace shared use parking bay and 24hr waiting restrictions with a daytime waiting restriction (Mon-Fri 8.30am-5.30pm) on Bellevue St; **3.** Replace pay and display bay and daytime waiting restriction with a 24hr waiting restriction on Dean Ter ; **4.** Replace pay and display bay and daytime waiting restriction with a 24hr waiting and loading prohibition on Raeburn Pl; **5.** Replace permit holder bay with a daytime waiting restriction (Mon-Fri 8.30am-5.30pm) on Ann St and Saint Stephen St; **6.** Replace a shared use parking bay with loading bay on Palmerston Pl; **7.** Replace permit holder bays with 24hr waiting restriction on Guthrie St; **8.** Replace shared use and pay and display bay with a daytime waiting restriction (Mon-Fri 8.30am-5.30pm) on Broughton Pl; **9.** Replace shared use parking bays with solo motorcycle bay on Drummond Pl and London St; **10.** Replace shared use bay with car club bay on Dublin St; **11.** Replace 24 hr waiting restrictions with a daytime waiting restriction (Mon-Fri 8.30am-5.30pm) on Devon Gdns; **12.** Remove 24 hr loading prohibition leaving only 24 hr waiting restrictions on Nightingale Way; **13.** Replace daytime waiting restriction with 24hr waiting restriction on Boroughloch; **14.** Replace permit holder parking bay with car club bay on East Suffolk Rd; **15.** Replace a shared use parking bay with a disabled persons' parking bay on London St; & **16.** Amend the parking holiday dates to take into account Sunday parking controls.
