Replace disabled persons' parking bay with a permit holders only bay on Drummond PI & Thirlestane Rd; 6. Replace disabled persons' parking bay with a shared use parking bay on Hillside St; 7. Extend disabled persons' parking bays on East Fettes Ave, King Edwards Way, Easter Drylaw PI & Maitland Hog La; & 8. Reduce a disabled person's parking bay on Walkers Rigg.
