THE CITY OF EDINBURGH COUNCIL (ABBEY LANE & ABBEYHILL/SPRING GARDENS) (NO. 2) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/243

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Abbey Lane & Abbeyhill/Spring Gardens) (No. 2) (Temporary Road Restriction and Traffic Regulation) Order 2023" and shall come into operation on the Ninth day of January Two thousand and twenty-four and shall remain in force up to and including the Thirtieth day of June Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4 of this Order, to facilitate a safe working area for nearby redevelopment works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on **Abbey Lane**, from its junction with Abbeyhill/Spring Gardens, north-eastwards for a distance of 90 metres or thereby; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i) **Abbey Lane**, from its junction with Abbeyhill/Spring Gardens, north-eastwards for a distance of 100 metres or thereby; and (ii) **Abbeyhill/Spring Gardens**, from a point 35 metres or thereby west of the extended north-western kerbline of Abbey Lane, generally eastwards to a point 30 metres or thereby south-east of the extended south-eastern kerbline of Abbey Lane.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 6. The alternative route for through vehicular traffic will be by way of Abbeyhill, Abbey Mount, Montrose Terrace, London Road, Meadowbank Avenue, Royal Park Terrace and Spring Gardens.
