THE CITY OF EDINBURGH COUNCIL (MARCHMONT ROAD AREA) (NO. 2) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/251

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Marchmont Road Area) (No. 2) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect from the First day of January Two thousand and twenty-four up to and including the Fourteenth day of April Two thousand and twenty-four.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "motor vehicle" has the same meaning as in Section 136 of the 1984 Act;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
 - "Schedule" means a Schedule to this Order;
 - "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate sewer installation works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on: (i) **Meadow Place**, at its junction with Marchmont Road; and (ii) **Warrender Park Terrace**, at its junction with Marchmont Road;
 - (b) drive or cause or permit any motor vehicle to be driven on **Marchmont Road**, between its junction with Melville Drive and its junction with Warrender Park Road, otherwise than in a *northbound* direction; and
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on: (i) **Marchmont Road**: (1) *west side*, between its junction with Melville Drive and its junction with Warrender Park Road; and (2) *east side*, from its junction with Melville Drive, southwards for a distance of 140 metres or thereby; and (ii) **Meadow Place**, *west side*, from its junction with Marchmont Crescent, northwards for a distance of 50 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(c) of this Order.
- 6. The alternative route for through vehicular traffic with respect to the *one-way restriction* will be by way of Melville Drive, Argyle Place, Warrender Park Road, Marchmont Crescent and Marchmont Road.

7. The alternative routes for through vehicular traffic with respect to the *closures* will be by way of: (i) **Meadow Place** – Meadow Place, Marchmont Crescent, Warrender Park Road and Marchmont Road; and (ii) **Warrender Park Terrace** – Warrender Park Terrace, Spottiswoode Street, Warrender Park Road and Marchmont Road.
