# THE CITY OF EDINBURGH COUNCIL (LONDON ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/30

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (London Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect from the Twenty-seventh day of January Two thousand and twenty-four and shall remain in force up to and including the Twenty-ninth day of March Two thousand and twenty-four.
- 2. In this Order the following phrases have the meaning respectively assigned to them: "Article" means an Article of this Order;
  "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;

"the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and

"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.

- 3. Save as provided in Article 4 of this Order, to facilitate resurfacing and public realm works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on the sections of roads described in Schedule 1 hereto;
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of the roads described in Schedule 2 hereto; and
  - (c) drive or cause or permit to be driven any vehicle on the road described in column 1 of Schedule 3 so as to make the prohibited turn specified in column 2 of Schedule 3, into the road specified in column 3 of Schedule 3 hereto.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order is hereby suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 'The City of Edinburgh Council (Cambusnethan Street, Edinburgh) (One-Way) Traffic Regulation Order 2010' will be suspended in relation to the *one-way restriction* on Cambusnethan Street, to facilitate two-way traffic for the time the road is closed at its junction with London Road.
- 7. 'The City of Edinburgh Council (Maryfield Place, Edinburgh) (One-Way) Traffic Regulation Order 2006' will be suspended in relation to the *one-way restriction* on Alva Place, to facilitate two-way traffic for the time the road is closed at its junction with London Road
- 8. The 'Edinburgh Corporation (Wishaw Terrace One-Way) (Traffic Regulation) Order, 1946' will be suspended in relation to the *one-way restriction* on **Wishaw Terrace**, to facilitate two-way traffic for the time the road is closed at its junction with London Road.

- 9. The alternative route for through vehicular traffic with respect to the *prohibited left turn* will be by way of Abbey Mount, Easter Road and London Road.
- The alternative routes for through vehicular traffic with respect to the *closures* will be by way of: (ii) Maryfield; and (iii) Alva Place London Road, Easter Road and Rossie Place; (iv) Abbey Lane Spring Gardens, Royal Park Terrace, Meadowbank Terrace and London Road; (v) Lower London Road London Road and Lower London Road; (vi) Cambusnethan Street London Road, Marionville Road and Cambusnethan Street; (vii) Wishaw Terrace London Road, Marionville Road and Wishaw Terrace; and (viii) Clockmill Lane London Road, Meadowbank Terrace and Royal Park Terrace.
- 11. The following road has no available diversion, where local access will be maintained: (i) **Abbey Street**.

#### SCHEDULE 1 ROAD CLOSURES

(i) **Abbey Street**, in its entirety; (ii) **Maryfield**, at its junction with London Road; (iii) **Alva Place**, at its junction with London Road; (iv) **Abbey Lane**, from its junction with London Road, southwards for a distance of 45 metres or thereby; (v) **Lower London Road**, from its junction with Abbey Lane, eastwards for a distance of 50 metres or thereby; (vi) **Cambusnethan Street**, at its junction with London Road; (vii) **Wishaw Terrace**, at its junction with London Road; and (viii) **Clockmill Lane**, at its junction with London Road.

## SCHEDULE 2 PROHIBITION OF WAITING, LOADING AND UNLOADING

(i) **London Road**, between its junction with Easter Road and its junction with Meadowbank Terrace; (ii) **Montrose Terrace**, from its junction with London Road, south-westwards for a distance of 90 metres or thereby; (iii) **Abbey Street**, from its junction with London Road, southwards for a distance of 50 metres or thereby; (iv) **Maryfield**, from its junction with London Road, northwards for a distance of 20 metres or thereby; (v) **Alva Place**, from its junction with London Road, northwards for a distance of 20 metres or thereby; (vi) **Abbey Lane**, from its junction with London Road, southwards for a distance of 50 metres or thereby; (vii) **Lower London Road**: (1) from its junction with Abbey Lane, eastwards for a distance of 50 metres or thereby; and (2) from its junction with London Road, westwards for a distance of 50 metres or thereby; (viii) **Marionville Road**, between its junction with London Road and the roundabout at Moray Park Terrace; (ix) **Cambusnethen Street**, from its junction with London Road, northwards for a distance of 30 metres or thereby; and (x) **Wishaw Terrace**, from its junction with London Road, northwards for a distance of 40 metres or thereby.
