THE CITY OF EDINBURGH COUNCIL (GRANGE ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/08

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Grange Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2024”. The order shall come into operation on the Nineteenth day of February Two thousand and twenty-four and shall remain in force up to and including the Nineteenth day of April Two thousand and twenty-four.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4 of this Order, to facilitate the removal of existing pedestrian signalised crossings and the installation of a new relocated raised signalised crossing and associated works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on (i) **Cumin Place**, from its junction with Grange Road, southwards for a distance of 45 metres or thereby; and (ii) **Tantallon Place**, from its junction with Grange Road, northwards for a distance of 25 metres or thereby; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i) **Cumin Place**, from its junction with Grange Road, southwards for a distance of 45 metres or thereby; (ii) **Grange Road**, from the centre line of its junction with Cumin Place, westwards for a distance of 50 metres or thereby and eastwards for a distance of 28 metres or thereby; and (iii) **Tantallon Place**, from its junction with Grange Road, northwards for a distance of 25 metres or thereby.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. The alternative routes for through vehicular traffic will be by way of: (i) **Cumin Place** – Grange Road, Lauder Road & Dick Place; and (ii) **Tantallon Place** – Grange Road, Lauder Road and Hatton Place; or Grange Road, St Catherine's Place and Sciennes Road.
